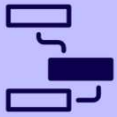

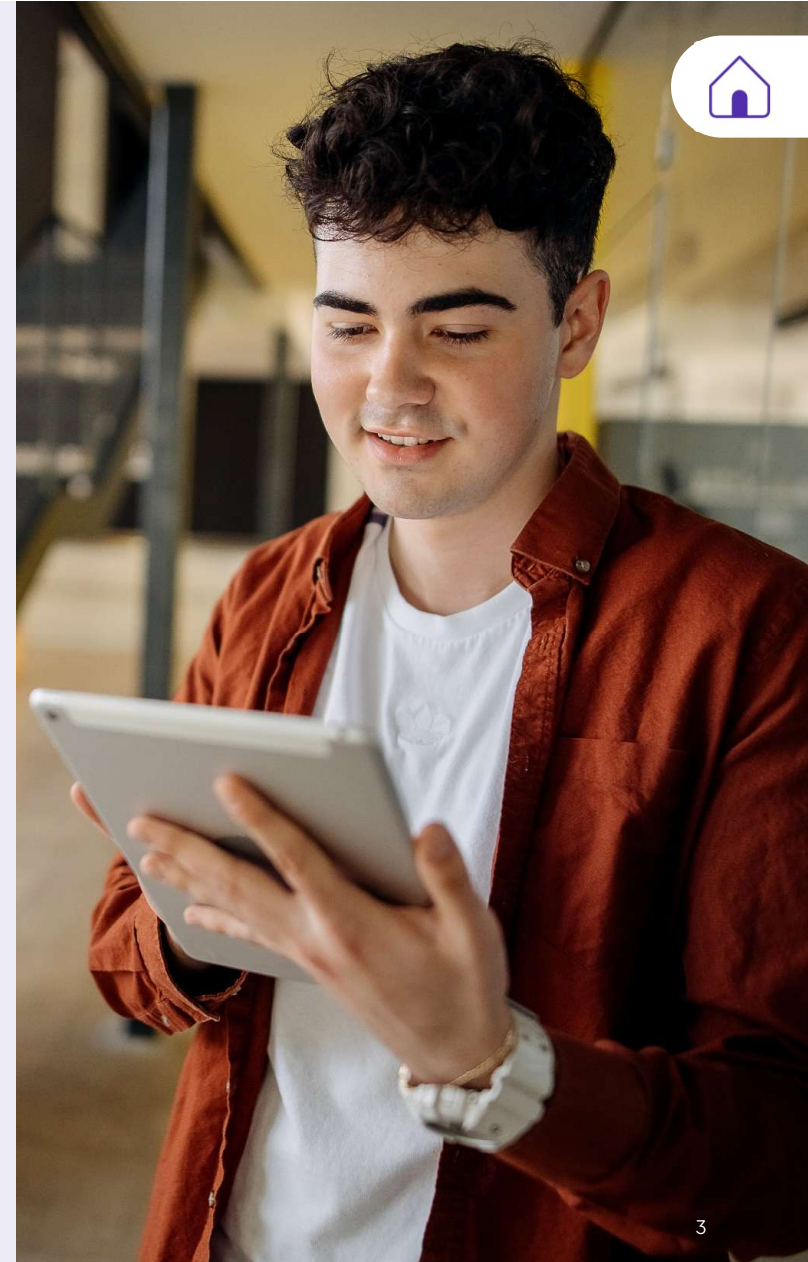

# Level 3 vocational qualifications

## V Level = 360 GLH

The government aims to have only one V Level in a subject.

Depending on the occupational route, there could be more than one V Level in a route. However, it has been confirmed there will only be one V Level per route in the initial 2027 qualifications.

## Exceptional case

Will consider whether a V Level may be 'partnered' with one other V Level from the same route. A maximum of two V Level subjects in the same route can be studied together for 720 GLH.

## Range of Subjects

DfE will continue to refine the range of subjects to ensure they relate to the priority areas of the economy, such as those linked to the growth-driving sectors as set out in the Industrial Strategy.

## T Levels

DfE will continue to test the viability of new T Levels including consideration of whether further design flexibilities are required and proportionate.





# Level 2 vocational qualifications

## Foundation Certificates

Size range of 240 to 300 GLH in a single year.

## Range of subjects

DfE will continue to refine the range of subjects to ensure they relate to the priority areas of the economy, such as those linked to the growth-driving sectors as set out in the Industrial Strategy.

## Occupational Certificates

- Variable in size – 540–720 GLH
- Two-year study programme.
- Support tailored to preparing students for entry to work and which aims to be enriching and inspiring.

## Foundation Certificates study programme

- Provides meaningful vocational area content and practical learning.
- Leaves sufficient time for English and/or maths.
- Ensures time for enrichment, employability, and pastoral (EEP) provision.
- Enables supported preparation for level 3.
- Provides flexibility for students with SEND or other forms of disadvantage.
- Fits within the expected hours of a full-time study programme.

# Summary of outcomes for Pearson BTEC qualifications

Confirms the introduction of new Level 2 pathways and a third vocational route at Level 3 – V Levels – alongside A levels and T Levels, recognising that learners need choice as they progress into work, further study or higher education.



# Funding in 2026/27

The government has confirmed that no additional existing qualifications will have their funding removed in 2026/27.

---

This means the following qualifications will remain funded:

- **BTEC National Extended Diplomas** (1,080 GLH) in Health and Social Care, Applied Science, IT, Computing, and Forensics.
- **BTEC National Diplomas** (720 GLH) in Health and Social Care, Applied Science, IT, Computing and Forensics.
- **BTEC National Foundation Diploma** in Forensics (510 GLH).
- **BTEC National Extended Certificate** (360 GLH) and Certificate (180 GLH) in Applied Psychology.



# Funding from 2027/28

Changes to qualification funding will begin on a phased basis.

---

## Level 3

- **BTEC National Extended Diplomas (1,080 GLH)** will have funding removed where a T Level is available.
  - As a result, Extended Diplomas in Agriculture, Animal Management, Business, Digital, Enterprise, Engineering, Horticulture and Forestry, Marketing, Media, and Science will no longer be available for new learners from 2027/28.
- **The BTEC National Extended Diploma** in Health and Social Care will remain available in 2027/28.
- **BTEC Nationals (720 GLH and below)** in IT and Computing will have funding removed and will be replaced V Level(s).
- **The BTEC National in Early Childhood Development (AAQ)** will have funding removed and will be replaced by the V Level.

## Level 2

- The Level 2 Technical qualification in Early Year Practitioners will have funding removed and will be replaced by new level 2 qualifications.



# Introduction of V Levels and Level 2 pathways

The government has confirmed that V Levels, and the two new Level 2 pathways will be first introduced from 2027/28 in a limited number of sectors.

## 2026/2027

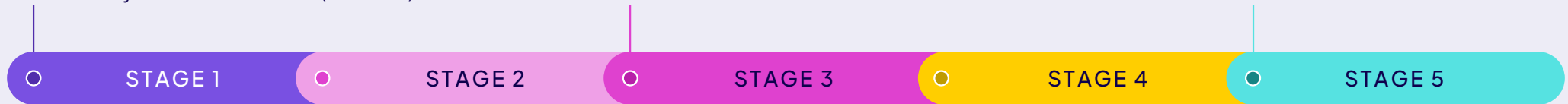
- No changes to defunding.

- Development of L2 and L3 qualifications in first four sectors – Tranche 1:
  - Finance and Accounting (L3 only)
  - Digital (L2 and L3)
  - Early Years and Education (L2 and L3)

## 2028/2029

- First teach Tranche 2.
- Defunding of corresponding legacy vocational.
- Development of Tranche 3.

## 2030/2031

- First Teach of Tranche 4.
- All industry routes (at Post-16 Level 2 and Level 3 V Levels available.
- Summer 2030 last stage of defunding for corresponding legacy vocational provision (at Level 2 and 3).



## 2027/2028

- Defunding of large BTECs in T level subjects.
- First teach Tranche 1.
- Development of Tranche 2 and new T Levels.

## 2029/2030

- First teach Tranche 3.
- Defunding of corresponding legacy vocational provision.
- Development of Tranche 4 and new T Levels.

# Important guidance on programmes of study: combinations

---

There are various factors to consider when devising a student's programme, including:

- their strengths, interests and intended progression destination
  - whether they need to continue with English/Maths alongside
  - any non-qualification activities they will be undertaking, e.g. work placement
- 

## **Avoid overlapping subjects**

Choosing combinations with a high proportion of overlap reduces student engagement and limits breadth in Level 3 programmes of study.

---



# Important guidance on programmes of study: progression

## One of the most important considerations when devising a programme of study is taking account of students' intended progression outcome.

Study programmes should align with students' intended progression goals, such as higher education aspirations. For example, many students taking the BTEC Level 3 Nationals will be intending, or hoping, to progress to HE.

For those intending to progress to HE, select subjects/ qualifications that cover a broad range of content and skills relevant to their intended degree specialism(s). This will help maximise their chance of successfully progressing to HE. Some universities have subject-specific entry requirements, particularly for STEM-related degrees, where they may require students to have studied specific subjects and/or specific A levels.

## Check entry requirements

Understanding varying university entry requirements is crucial for guiding students effectively.

At present, a few selective UK universities do not accept students with more than one vocational qualification at Level 3. Where universities do accept students holding more than one BTEC qualification, they generally expect this to be in separate subject disciplines and do not accept combinations with a high degree of overlap, irrespective of UCAS points.

It is important to check that your student's intended destination(s) accept the combination(s) you are considering delivering.

Where students have yet to decide which university and/or degree they wish to progress to, it is worth asking your main recruiting universities for their views on your proposed combination.

# FAQS



## Why are post-16 vocational qualifications changing?

The post-16 vocational qualification reforms are designed to create clearer routes for learners and simplify progression after GCSEs. At Levels 2 and 3, qualifications will be grouped into the following distinct categories, with each qualification type having a defined purpose and progression outcome:

- V Levels at Level 3, supporting progression to higher education, higher-level study or apprenticeships.
- Foundation Certificates at Level 2, supporting progression to further Level 2 or Level 3 study.
- Occupational Certificates at Level 2, supporting progression towards skilled employment or an apprenticeship.

The aim is to help learners, families and educators understand where each route can lead and make choices with greater confidence.

## How do V Levels compare to A levels and T Levels?

A Levels, T Levels and V Levels are all Level 3 qualifications, but they are designed for different learning styles and progression routes.

- A Levels are academic, subject-based qualifications.
- T Levels are large technical qualifications designed around a particular occupational route. They include a

substantial industry placement.

- V Levels are broad vocational qualifications that use applied learning and practical assessment but do not focus as narrowly on one occupation as T Levels.

The right choice at Level 3 will depend on how a learner prefers to learn and what the learner wants to do next.

## Can learners combine V Levels with A levels and other qualifications?

Yes. V Levels are designed to be studied alongside other qualifications, giving learners flexibility to build a programme around their interests, strengths and future plans.

- a V Level with one or more A Levels
- different V Levels or funded BTECs
- V Levels with English or Maths resits

Because a V Level is equivalent in size to one A Level, it can support mixed academic and vocational programmes. This may suit learners who want applied learning while keeping a range of higher education, apprenticeship and employment options open.

## Will V Levels include an industry placement?

V Levels will not require the substantial industry

placement that forms part of a T Level. V Levels are classroom-based vocational qualifications, although their applied learning and practical assessment will connect knowledge to relevant occupational standards and future study or work. Individual schools and colleges may offer additional work-related experiences as part of their wider study programmes, but are not compulsory.

## How are employers and occupational standards involved in V Levels?

V Level content will be linked to occupational standards, helping to connect learning with the knowledge and skills relevant to future study and work.

Pearson is also inviting teachers, education leaders, employers and sector experts to contribute feedback as the new qualifications are developed.
