<p>Comments:</p> <p>The evidence relating to this strand is under the link Project Proposal. There is a Proposal document which describes the product to be produced which is a spreadsheet. 18.3.08 is given as the deadline for the handover. Personnel practices are addressed. Risks in this document relate to the product rather than the project. Stakeholders are mentioned and there is an agreement to proceed which is correct practice although it would be helpful to have included the date this was signed. There is a Definition of Scope which is well presented. This includes the objectives of the project and makes an attempt to address key success criteria too. The date of 18.3.08 is confirmed. The risks to the project are address but very weakly. The interim review dates and project roadmap are also covered. There is also a separate document detailing the stakeholders and this relates to 8.2 of the unit specification. There is sufficient evidence to access all the marks in MB2.</p> <p>Mark Awarded: 5</p>

Comments:

There is a section called Planning. The candidate has used project management software and produced the plans in pdf format which is correct procedure and enables all the marks in this strand to be accessed. The plan and updates are explained. Risks are included in the form of leeway. The progress can be followed also by the completed tasks being ticked off. The date of 18.3.08 was met. The only aspect not addressed is the categorising of risks and this was not done in strand a either. The evidence fits MB3 but is unable to access all the marks because of this weakness.

Comments: There is a section called Communication. This has links to the months which contain the relevant communication evidence for that month. There are links to Agendas and Action Minutes. These are dates and list the attendees. There are also links to informal communication such as telephone calls, contact with peer reviews, emails. There is a link to Progress Reports although these seem to be summaries resulting from the meetings which is one approach to this. The meetings are clearly progressing the product and there is some reference to the handover date although this is the only reference to the plan. The End of Project Review Meeting is held on 13.3.08 which is before the final date of 18.3.08. The emails suggest that the meeting is going to take place on 18.3.08 still as they are dated 15 and 17 March. The February meeting says 18.3.08 for next meeting. It may be that 13 was a typo and it should have been 18. Benefit of the doubt has been applied as all other			

evidence does refer to 18.3.08. There is some evidence showing the candidate reacted to feedback in the minutes. There is insufficient reference to the plan to support MB3 but all the marks in MB2 are addressed.

However, there is sufficient evidence to access all the marks in MB2. QWC – many of the sentences are not well constructed and would benefit from more accurate punctuation. Some adjustment is made to take this into account.</p> <p>Mark Awarded: 8</p>
