

Scaling on English AS and A Levels

Please be aware that the raw mark total (that achieved by adding together the marks available for each component as listed in the specification) for most A level and 1 AS component is different to the subject mark total. The raw marks for each component need to be scaled and then added together in order to achieve the subject mark. The notional, paper level grade boundaries reflect the unscaled totals.

The actual grade boundaries for each of our English AS and A levels are given at qualification level (using scaled subject marks) as these are linear qualifications awarded at qualification not paper level. Please see the table below for details of the scaling.

Example for 8ET0

The total subject mark is 120. Raw marks for 8ET0/02 require multiplying by 1.091 to scale the paper to represent 40% if marks for each paper are being combined and compared to the qualification grade boundary.

Scaling is referred to on page 9 of the AS specification:

'Centres are reminded that the marks given are raw marks and as such will be scaled to reflect the appropriate component weighting for results purposes.'

When using grade boundaries for internal marking purposes, you will need to scale your students' paper 2 results, multiplying raw marks out of 44 by 1.091.

Candidate Statements of Provisional Results only show the grade for a linear qualification. The centre receives a 'component mark' list that shows, for each candidate, the overall subject mark plus the <u>raw</u> (ie not scaled) mark achieved on each component, along with the scaling factor for the component. In the example of 8ETO, the scaling factor of 1.091 is shown on this component mark list.

Using grade boundaries to make decisions on whether to request a review of marking

Component level grade boundaries for linear qualifications are notional, and achieving a raw mark that equates to a 'grade A' at component level, has no immediate bearing on the grade that will be awarded at qualification level once raw marks have been scaled and totalled to arrive at the total subject marks. This should be considered when deciding whether to apply for a review of marking (an EAR). A change in a raw mark that results in a change in 'grade' at component level may not equate to a change in grade at qualification level.

Candidate X is 10 scaled marks away from a grade A. Assuming that the marks for 9ET0 04 (non-examined assessment) are not under discussion, the candidate would need to see a mark change of at least 7 raw marks on 9ET0 01, 9ET0 02 or 9ET0 03 in order to achieve a grade change to grade A (7 raw marks $\times 1.5 + 10.5$ scaled marks).

A 2 raw mark increase on 9ETO 01 following a review of marking would result in candidate X receiving a notional 'A' on this paper (as the raw component grade boundary for an A is 37 raw marks), but this would not result in a change to the overall qualification grade (2x1.5=3 scaled marks, so the scaled total subject marks would become 200, 7 short of the marks required for an A at qualification level).
