

















































The focus is on the nature and purpose of the work of historians, and why they differ. It cannot duplicate the issues covered in Paper 1, Section C.</p> <p>A piece of extended writing of 3000-4000 words which addresses the issue of historical interpretation.</p> <p>Internally marked and externally moderated, and worth 20% of the total A Level mark.</p> <p>It must:</p> <ul style="list-style-type: none"> • be independently researched and written • draw upon the student's study of at least three secondary works, or extracts from secondary works, which offer differing interpretations of the their chosen topic • analyse, explain and evaluate historians' arguments

Key Similarities

- topics which allow students to study a chronological range of at least 200 years
- substantial elements of both British and non-British history
- topics which allow students to demonstrate understanding of the process of change, both long term and short term
- topics which allow students to develop an understanding of the nature and purpose of history as a discipline and enable them to carry out a historical enquiry that is independently researched.

Key Benefits of the Edexcel Specification

- The 'pathway' approach in Papers 1 and 2 allows students to develop a more thematic approach to study across periods and countries
- Assessment over four components rather than three allowing the weighting of marks to be spread and the burden of individual examinations to assessments to be lessened
- Greater choice of topics relating to Britain, Europe and the World
- Greater scope to combine topics allowing students a more varied experience
- Coursework allows students to choose historical controversies from within units already taught for Papers 1, 2 and 3
- Coursework does not contribute to the 200-year minimum programme of study requirement
- No requirement to submit coursework proposal forms for each student at least 12 months prior to the end of their A Level course (though a free assignment guidance service is available)
