## Judaism

Judaism is very much a religion oriented towards practical perfection in this world ... This practical orientation finds its concrete expression in the codified norms of Torah-based behaviour called *Halakhah* or Jewish Law. While much of Halakhah is given over to what we would today call religious or ritual law, it encompasses civil, criminal and moral law as well. The moral component, however, is not distinguished in any way from other components of Halakhah and, at least from within the system, is seen as drawing its authority, as does the rest of the Torah, from God's command. Since Halakhah contains an ethical component it must be asked whether 'the Jewish tradition recognises an ethic independent of Halakhah'. Can there be, that is, significantly *Jewish* ethical norms not included in Halakhah?

This is a thorny problem.
