Set Task Brief

Newgrange Nursery is a large nursery school that provides government funded part-time nursery education for up to 100 children. Children enter the nursery school in the term after their third birthday.

On average there are about 50 children attending any one session. The vast majority of children are of White British background. The proportion of disabled children and those who have special educational needs is above the national average.

There have been recent staff changes at Newgrange Nursery and a new head teacher was appointed six months ago. The nursery school shares accommodation and some specialist staff with the Newgrange Children's Centre.

Set Task

You must complete ALL activities within the set task.

Activity 1

The head teacher at Newgrange Nursery has just received its latest Ofsted report. The quality of the provision is good. The report states what the nursery needs to do to improve:

- *Enable children to have more opportunities to develop early skills of writing as part of learning through play*
- *Ensure all staff encourage children's communication skills when learning through play, by giving appropriate support and guidance that makes the most of learning in all activities promoting development*
- *Ensure all staff have a thorough knowledge of how speech and language link to other areas of development.*

Produce a report responding to Newgrange Nursery's latest Ofsted report.

You must:

- make recommendations for the nursery school
- describe the resources required
- describe the role of the early years educators and specialist staff
- justify improvements that link best practice to early years theory.
