Overview

The countryside management sector

Working in the countryside management sector is often overlooked as a career. However, it has a wide range of progression and job opportunities. The game and wildlife industry employs approximately 73,000 people in the UK, with approximately 31,000 people employed in the countryside industry. The number of people working in this area is expected to grow each year, and employment opportunities can be found in both urban and rural areas.

Who is this qualification for?

The Pearson BTEC Level 3 National Foundation Diploma in Countryside Management, which is 540 GLH, is intended as a Tech Level qualification, equivalent in size to 1.5 A Levels and, as such, is designed to meet the Tech Bacc measure, if you study it alongside level 3 mathematics and the Extended Project Qualification (EPQ).

It is a one-year full-time course that provides a comprehensive introduction to the sector and is primarily for those intending to gain employment directly, or to progress to an apprenticeship or a higher-level countryside management qualification.

No prior study of the sector is needed, but you should normally have a range of achievement at level 2, in GCSEs or equivalent qualifications, including English, mathematics and science.

What does the qualification cover?

The content of this qualification has been developed in consultation with employers and professional bodies to ensure that it is appropriate for those interested in working in the sector. In addition, higher education representatives have been involved to ensure that it fully supports entry to the relevant range of specialist degrees.

There are five mandatory units, which cover the following aspects of countryside management:

- professional working responsibilities
- plant and soil science
- work experience in the land-based sectors
- countryside estate skills activities
- management of environmental habitats.

You will be able to add two optional units to the mandatory content. These have been designed to support your progression to a range of employment opportunities in the countryside management sector and, when taken alongside other level 3 qualifications, to a range of higher education courses.

Optional units will introduce you to a sector specialist area of your choice, including working in particular environments, and link with relevant occupational areas. The optional units cover areas such as:

- land-based machinery operations
- wildlife ecology
- woodland management
- identification, planting and care of trees
- developing a land-based enterprise
- controlling countryside pests and predators
- gamekeeping.

While taking this qualification, you will be required to engage with sector employers as part of your course, including 150 hours of work experience with an employer in the sector, where you will be given opportunities to develop practical skills in preparation for employment.

What could this qualification lead to?

Will the qualification lead to employment, if so, in which job role and at what level?

This qualification will prepare you for direct employment in the countryside management sector, and is suitable if you wish to enter a particular specialist area of work, such as:

- estate operative
- fieldwork assistant
- assistant warden.

Will the qualification lead to further learning?

If you complete this qualification in a year, you may progress to further learning at level 3; for example, a second BTEC Foundation Diploma in a complementary sector, or a larger size BTEC National in Countryside Management.

When achieved alongside other level 3 qualifications as part of a two-year programme of study, you will be able to progress to a range of degree programmes in the countryside management sector.

The qualification carries UCAS points and is recognised by higher education providers as contributing to meeting admission requirements to many relevant courses. For example, if taken alongside AS/A Levels in Biology and Chemistry, it could lead to a:

- BSc (Hons) in Countryside and Environmental Management
- BSc (Hons) in Countryside Management
- BSc (Hons) in Landscape Management
- FdSc in British Wildlife Conservation.

The qualification could also lead to a BSc (Hons) in Business Management, if taken alongside AS/A Level Business and a Pearson BTEC Level 3 National Certificate or Extended Certificate in Information Technology.

You should always check the entry requirements for degree programmes at specific higher education providers.

Why choose this size of qualification?

If there are larger and/or smaller versions of this qualification, or it is available at different skills levels, why should you take this particular one?

The **Pearson BTEC Level 3 National Foundation Diploma in Countryside Management** is equivalent in size to 1.5 A levels. It is ideal for you if you are looking for a one-year course of full-time study, perhaps after taking further level 2 qualifications, and are intending to gain employment directly in roles such as an estate operative, fieldwork assistant or assistant warden, or to progress to an apprenticeship in countryside management.

The suite also includes the following qualifications:

The **Pearson BTEC Level 3 National Extended Certificate in Countryside Management**, which is the smallest qualification in the suite of BTEC Nationals in Countryside Management and is equivalent in size to 1 A level. It is ideal for you if you are interested in learning about the countryside management sector, with supplementing fields of study. It will prepare you for an entry-level role, such as a trainee estate operative or a trainee reserve warden. If you take it alongside other level 3 qualifications, it may prepare you for a higher/degree apprenticeship, or, alternatively, it may enable you to progress to a sector-related degree before entering the countryside management sector at a higher level.

The **Pearson BTEC Level 3 National Diploma in Countryside Management**, which is equivalent in size to 2 A levels. Its size means there is time in a two-year full-time study programme to take an additional level 3 qualification, such as one of those listed above, to support progression to more specialist employment or to higher level study prior to entering employment in the countryside management sector.

The **Pearson BTEC Level 3 National Extended Diploma in Countryside Management**, which is equivalent in size to 3 A levels, and is typically the sole qualification in a two-year full-time 16-19 study programme. It is ideal for you if you know that you want to work in the countryside management sector as it allows you to focus all of your study on the sector. The qualification does meet entry requirements for a range of higher education programmes and so you could take a sector-related degree before entering employment in the sector at a higher level.
