Statement of Purpose

500/6245/1 – Pearson BTEC Level 3 Subsidiary Diploma in Understanding Enterprise and Entrepreneurship (QCF)

With 60% of companies in the UK being SMEs (accounting for 50% of the country's revenue), there has been a significant focus in recent years within industry and government on the potential impact of enterprise and entrepreneurship on the economy, with David Cameron saying in a recent speech: *'It is by backing our entrepreneurs and championing small business that we can drive forward and grow the economy, and equip this country for the highly competitive era we are in'.* Organizations like the Peter Jones Foundation, the Gazelle Group of Colleges and Global Entrepreneurship Week have developed approaches to business with enterprise and entrepreneurship at their heart to help foster a new generation of social and commercial entrepreneurs who can add value to communities, bring innovation to existing businesses and create their own employment with confidence and ambition.

The Pearson BTEC Level 3 Subsidiary Diploma (360 GLH) in Understanding Enterprise and Entrepreneurship is part of a larger suite of Enterprise and Entrepreneurship qualifications, in a range of sizes, which share the common purpose of helping people to become occupationally ready to take up employment in a variety of industry sectors at the appropriate level, or to start their own business. This can follow either directly after achieving the qualification, or via the stepping stone of Higher Education (HE) in university or college. By studying a BTEC National, learners develop knowledge, understanding and skills required by the sector, including essential employability skills, and apply them in real work contexts. Learners can operate at a standard that can reasonably be expected of an 18 year old in full-time education.

The Pearson BTEC Level 3 Subsidiary Diploma in Understanding Enterprise and Entrepreneurship (360 GLH) is primarily an Applied General qualification, equivalent in size to an A level, which has been designed to occupy one third of the curriculum within a broader programme of study, which could include other vocational or academic qualifications. Its main purpose is to allow learners to develop the core specialist knowledge, understanding and skills, including business planning and pitching, and leadership and teamwork required by the sector. It provides a basis for progression into a broad range of roles within the sector when supported by relevant qualifications at level 2, such as GCSE English and mathematics, and/or at level 3, such as a GCE A Level in Law, or a Pearson BTEC Level 3 Certificate in Fashion and Clothing. Learners have some opportunity to study in more depth a range of option areas of their choice, including:

- Unit 10: Market Research Analysis
- Unit 13: E-marketing and Website Design
- Unit 14: Brand Development and Promotion.

As the qualification was designed in close collaboration with industry, it is fully supported by the Sector Skills Council (SSC) for the sector, SFEDI. A range of professional organisations/employers in the sector has also confirmed their support for this Pearson BTEC Level 3 Subsidiary Diploma in Understanding Enterprise and Entrepreneurship. This means it is a highly respected route for those who wish to move into employment in the sector, either directly or following further study.

Many learners will study for this qualification with a view to setting up their own business or perhaps seeking employment within a recent start-up company. Others might seek to specialise further by progressing onto a relevant degree in the specific sector they're interested in, and for those learners the Pearson BTEC Level 3 Subsidiary Diploma in Understanding Enterprise and Entrepreneurship provides a well-established route into a variety of Higher Education (HE) courses, when taken alongside other qualifications appropriate for the desired course of study.
