

Guidance for Centres for Work Placement. BTEC RQF and BTEC QCF nationals in Health and Social Care.

Academic year 2021/2022

Unit 6: Work experience in Health and Social Care.

Work Experience is an integral part of BTEC National in Health and Social Care and is valuable for both learners progressing on to vocational degrees such as nursing or those moving on to an apprenticeship in either health or social care. The requirement for unit 6 is that learners complete 100 hours in placement in a health or social care setting. If learners can attend placement then there is no requirement for the full 100 hours to be completed whilst placements are disrupted or unavailable due to the covid 19 pandemic. Placement attendance forms should be completed to record the hours learners were able to attend. The amount of time they attend should be sufficient to complete the unit assignment if they are going to complete the whole assignment on their placement.

We recognise with the current situation it is likely that many settings will not be accepting learners on placement. Unit 6 is an optional unit on the BTEC National Foundation and BTEC National Diploma and mandatory for the BTEC National Extended Diploma. This means that learners registered on the Foundation Diploma and the Diploma will also need to complete all of unit 6 to meet the requirements to claim this unit if they are then going to top up to the BTEC national extended diploma. Therefore, the option of selecting another optional unit may not be appropriate.

Before looking at adapted assessment it may be worth considering if other less traditional placements may be an option.

Widening the Range of Placements and activities

It is likely that hospitals and care homes will not be available for some or all of the duration of next year. Other possible placements may be accessed perhaps by providing remote support to vulnerable service users. Placements should still be working within the sector.

Using Volunteering

Working as a volunteer related to health, social care or youth work. This may also be a less possible however the following websites may be useful.

As with all placements it is important to ensure the safety of the learner and consider the safety of the people the learners will be working with.

These potential placements may not allow the full 100 hours but as long as there is sufficient for learners to complete the unit these will can be waived for the academic year 20/21whilst we are regulated by the Extended Extraordinary Regulated Framework (EERF).
