Overview***The health and social care sector***

The health and social care sector comprises two sub sectors; health care and social care. Health care encompasses all hospital activities, medical nursing homes and GP services, for example. The social care sector includes residential nursing care, residential nursing facilities, residential care facilities, domiciliary care and social work.

The sector is a major employer, employing almost four million people across the UK.

Who is this qualification for?

This qualification aims to provide an introduction to study of the sector and is for students interested in learning about the health and social care sector as part of a balanced study programme. It is intended as an Applied General qualification, and is equivalent in size to 0.5 of an A level. It supports access to a range of higher education courses, possibly in the health and social care sector, if taken alongside further level 3 qualifications.

No prior study of the sector is needed, but students should normally have a range of achievement at level 2, in GCSEs or equivalent qualifications.

What does the qualification cover?

The content of this qualification has been developed in consultation with higher education to ensure it supports progression towards higher study. In addition, employers and professional bodies have been involved, in order to confirm that the content is also appropriate for those interested in working in the sector.

All the content of the qualification is mandatory and must be passed in order for the qualification to be awarded. The units are:

- Human Lifespan Development
- Meeting Individual Care and Support Needs.

What could this qualification lead to?***Will the qualification support progression to further learning, if so, what to?***

Students wanting to continue their studies in Health and Social care could progress to a larger version of the qualification, for example, the Pearson BTEC Level 3 National Diploma in Health and Social Care.

Because the Pearson BTEC Level 3 National Certificate in Health and Social Care is generally taken alongside other qualifications as part of a 2-year programme of learning, students will be able to choose a wide range of degree programmes to progress to.

The qualification is intended to carry UCAS points and is recognised by HE providers as contributing to meeting admission requirements to many relevant courses, the other qualifications will make up the majority of the study programme and are more likely to shape the direction of further study. The qualification will particularly support entry to degrees where knowledge of the sector is relevant. For example, if taken alongside:

- Pearson BTEC Level 3 National Foundation Diploma in Children's Play, Learning and Development, it could lead to a Foundation Degree in Early Years Playwork and Education
- A level in Biology and further level 3 qualifications, such as A levels in Psychology, Maths or Science, it could lead to a BSc (Hons) in Nursing
- Pearson BTEC Level 3 National Diploma in Applied Science and an AS in Computing, it could lead to a BSc (Hons) in Biomedical Science.

Students should always check the entry requirements for degree programmes at specific HE providers.

Will the qualification lead to employment, if so, in which job role and at which level?

This qualification is designed primarily to support progression to employment via higher education. It also supports students choosing to progress directly to employment, as the transferable knowledge, understanding and skills will give successful students an advantage when applying for a range of entry level roles.

If there are larger and/or smaller versions of this qualification, or it is available at different skills levels, why should the student choose this one?

The **Pearson BTEC Level 3 National Certificate in Health and Social Care** is the smallest qualification in the suite of BTEC Nationals in Health and Social Care, it is equivalent in size to 0.5 of an A level. It is for students interested in learning about the sector, with a view to progressing to wide range of HE courses.

The suite also includes:

The **Pearson BTEC Level 3 National Extended Certificate in Health and Social Care** is equivalent in size to 1 A Level. It is for students interested in learning about the health and social care sector alongside other fields of study, probably with a view to progressing to a wide range of HE courses, not necessarily in the health or social care sector.

The **Pearson BTEC Level 3 National Foundation Diploma in Health and Social Care** is equivalent in size to 1.5 A levels and is for students looking for a one-year course, perhaps after taking further level 2 qualifications, or alternatively for study alongside another Foundation Diploma as part of a two-year programme.

The **Pearson BTEC Level 3 National Diploma in Health and Social Care** is equivalent in size to 2 A levels and is for students intending to study further, probably towards a degree in the health and social care sector, alongside a further qualification related to their chosen field.

The **Pearson BTEC Level 3 National Extended Diploma in Health and Social Care** is equivalent in size to 3 A levels and is for students who know they want to progress to health or care degrees in higher education before entering employment.
