Overview

The health and social care sector

The health and social care sector comprises two sub sectors; health care and social care. Health care encompasses all hospital activities, medical nursing homes and GP services, for example. The social care sector includes residential nursing care, residential nursing facilities, residential care facilities, domiciliary care and social work. Students are able to progress into work in the sector through degree programmes in nursing, midwifery, social work, physiotherapy, occupational therapy and pharmacy, for example. There are more than 300 distinct career paths in this sector.

The sector is a major employer, employing almost four million people across the UK.

Who is this qualification for?

The qualification is a one-year full-time course that gives a coherent study of the sector. It is intended as an Applied General qualification, and is equivalent in size to 1.5 A levels. It supports access to a range of higher education courses, most likely but not exclusively in health and social care disciplines, if taken alongside further level 3 qualifications.

No prior study of the sector is needed, but students should normally have a range of achievement at level 2, in GCSEs or equivalent qualifications.

What does the qualification cover?

The content of this qualification has been developed in consultation with higher education to ensure it supports progression towards higher study. In addition, employers and professional bodies have been involved, in order to confirm that the content is also appropriate for those interested in working in the sector.

The mandatory units for the qualification are:

- Human Lifespan Development
- Working in Health and Social Care
- Meeting Individual Care and Support Needs
- Principles of Safe Practice in Health and Social Care.

Students are able to select two option units that support their progression to specialised degree programmes, and which cover the biological and sociological topics relevant to the different parts of the sector.

Students are able to choose to take work experience as part of the course, to develop a better understanding of the demands of working in the sector.

What could this qualification lead to?

Will the qualification support progression to further learning, if so, what to?

Students are able to progress to the Pearson BTEC Level 3 National Extended Diploma in Health and Social Care.

Because the Pearson BTEC Level 3 National Foundation Diploma in Health and Social Care is generally taken alongside additional qualifications, as part of a two-year programme of learning, students will be able to choose a wide range of degree programme to progress to.

The qualification is intended to carry UCAS points and is recognised by HE providers as contributing to meeting admission requirements to many relevant courses. For example, if taken alongside:

- Pearson BTEC Level National Foundation Diploma in Applied Science, it could lead to a BSc (Hons) in Applied Social Science
- AS level in Sociology and a Pearson BTEC Level 3 National Extended Certificate in Children's Play, Learning and Development, it could lead to a BA (Hons) in Social Work
- Pearson BTEC Level 3 National Foundation Diploma in Sport, it could lead to BSC (Hons) in Physiotherapy.

Students should always check the entry requirements for degree programmes at specific HE providers.

Will the qualification lead to employment, if so, in which job role and at which level?

This qualification is designed primarily to support progression to employment via higher education. It also supports students choosing to progress directly to employment as the transferable knowledge, understanding and skills will give successful students an advantage when applying for a range of entry level roles, industry training programmes and Higher Apprenticeships, for example, the Adult Social Care Apprenticeship or the Allied Health Profession Support Apprenticeship.

If there are larger and/or smaller versions of this qualification, or it is available at different skills levels, why should the student choose this one?

The **Pearson BTEC Level 3 National Foundation Diploma in Health and Social Care** is equivalent in size to 1.5 A levels and is for students looking for a one-year course, perhaps after taking further level 2 qualifications, or alternatively to study alongside another Foundation Diploma as part of a two-year programme.

The suite also includes the following qualifications:

The **Pearson BTEC Level 3 National Certificate in Health and Social Care** is the smallest qualification in the suite of BTEC Nationals in Health and Social Care, it is equivalent in size to 0.5 of an A level. It is for students interested in learning about the sector, with a view to progressing to wide range of HE courses.

The **Pearson BTEC Level 3 National Extended Certificate in Health and Social Care** is equivalent in size to 1 A Level. It is for students interested in learning about the health and social care sector alongside other fields of study, probably with a view to progressing to a wide range of HE courses, not necessarily in the health or social care sector.

The **Pearson BTEC Level 3 National Diploma in Health and Social Care** is equivalent in size to 2 A levels and is for students intending to study further, probably towards a degree in the health and social care sector, alongside a further qualification related to their chosen field.

The **Pearson BTEC Level 3 National Extended Diploma in Health and Social Care** is equivalent in size to 3 A levels and is for those students who know they want to progress to health or care degrees in higher education, before entering employment.
