Outcomes of the review

Qualifications

We have removed qualifications with low and no enrolments, and considered which qualifications are needed in each route. We have looked at the needs of learners and the economy. **We will retain 157 qualifications in the system that were previously scheduled to be defunded.** The length of time qualifications will be retained depends upon the needs of each route. Where qualifications need to be retained in the longer-term, they will need to be reformed to improve their quality.

Rules of combination

We will not tell providers and students which types of qualifications they can and cannot mix together. It should be for colleges and sixth forms to work with students to devise the best mix for each individual. **We will therefore not be applying the previously proposed rules of combination.**

Certainty

We have provided clarity for education providers, students, and their families to make the position clear up to 2027. Qualifications that need to be retained longer-term will be reformed.

In the Spring, we will invite awarding organisations to submit new level 3 qualifications in key areas such as adult social care, health and science, construction, digital, education and early years, and care services. This will continue the process of reforming these routes whilst the Curriculum and Assessment Review looks at the curriculum more broadly.

Key outcomes

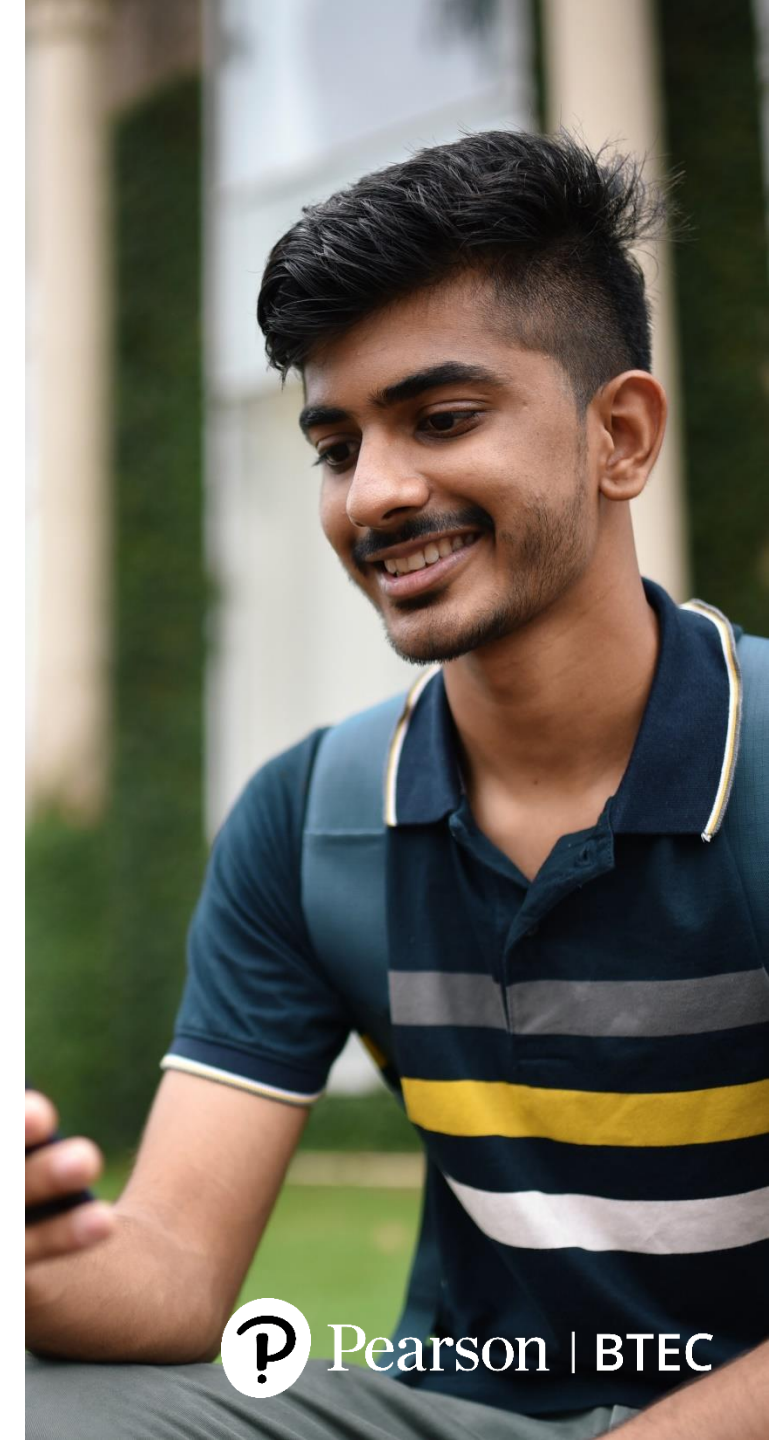
AAQs and Technical Qualifications in Cycle 1 subjects will continue to be first teach September 2025.

All RQF BTEC Nationals 180/360 GLH qualifications in these sectors remain defunded from 31 July 2025 and are replaced with our new BTEC National AAQs and Technicals.

The '1 AAQ and 2 A level' study programme rule has been scrapped. Centres can continue to create study programmes that are right for their learners.

Each sectors' qualification availability and funding reviewed independently and has a bespoke outcome.

Level 2 Cycle 1 will continue to be first teach September 2025.

Centres will need to ensure they check before registering learners that a qualification is funded in their region and for purpose of study.
