# Pearson BTEC Level 2 Award for Close Protection Operatives in the Private Security Industry (Refresher)

This qualification is now available for registration. It is aimed at those who need to renew their SIA Close Protection licence. From 1<sup>st</sup> April 2026 individuals will not be able to renew their Close Protection licence if they do not hold this qualification.

This qualification is made up of three mandatory units:

- Principles of Working as a Door Supervisor in the Private Security Industry (Refresher)
- Application of Physical Intervention Skills in the Private Security Industry (Refresher)
- Application of Physical Intervention Skills for Close Protection Operatives in the Private Security Industry (Refresher)

Please note these are new units, as indicated by '(Refresher)' in the title. There is no RPL from the 2021 and 2022 Door Supervisor and Close Protection qualifications allowed for this qualification. Units achieved in the 2021 and 2022 Door Supervisor and Close Protection qualifications (without '(Refresher)' in the title) cannot be used towards the Close Protection (Refresher) qualification.

#### **Delivery Time**

As this is a Refresher qualification, there is an expectation that learners will come to the course with a higher degree of knowledge, skills and understanding than learners attending security training for the first time. As such, the delivery time for the units within this qualification is less than that mandated for the related units within the 2021 and 2022 Door Supervisor and Close Protection qualifications. Please see the table below for the permitted self-study and mandatory contact time for each of the units.

### Application of Physical Intervention Skills for Close Protection Operatives in the Private Security Industry (Refresher) Unit

As this unit is aimed solely at refreshing skills, the SIA decided the focus of this unit should be on a select number of practical skills, rather than all the competencies contained within the related 2022 unit. This approach is intended to promote a higher degree of practice, leading to increased competence in certain skills through repetition and (where reasonable) increased levels of application intensity through scenarios.

Please note that there are no new techniques included in either of the physical intervention units.

## Pearson BTEC Level 2 Award for Close Protection Operatives in the Private Security Industry (Top Up)

This qualification expired for registration on 31st October 2025. Learners registered on this qualification must be certificated by 31st January 2026. Please make sure learners have sat the external tests and the internal units have been claimed on EOL by mid-January to ensure learners can be certificated before the last certification date. Learners holding this qualification must apply for their Close Protection licence renewal by 31st March 2026. All licence renewal applications made from 1st April 2026 will be required to hold the Close Protection (Refresher) qualification.
