# 1 Introduction

# 2 Subject content and assessment information

# Qualification aims and objectives

The overall aim of the qualification is to recognise achievement for students who are working below GCSE level.

It also aims to develop students' knowledge and understanding of:

- key beliefs, teachings and practices for two religions
- sources of wisdom and authority as well as forms of expression and ways of life
- key aspects of religious philosophy and ethics.

## Overview

Paper 1 comprises two sections: 1) Beliefs and teachings; and 2) Practices. It mirrors the content covered in Sections 1 and 2 of the Edexcel GCSE in Religious Studies A, Paper 1A Catholic Christianity.

# Content

Sub-topic	Students need to know and understand:
1.1 The Trinity	<ul><li>The nature of the Trinity:</li><li>God as Father, Son and Holy Spirit</li><li>the oneness of God in three persons.</li></ul>
	<ul> <li>The Trinity described in the Nicene Creed:</li> <li>God as maker of heaven and earth</li> <li>the Holy Spirit as the giver of life, who has spoken through the prophets.</li> <li>God the Son, who became human to save all people.</li> </ul>
	<ul> <li>How the Trinity is reflected in worship and belief for Catholics today:</li> <li>in pouring of water during baptism</li> <li>making the sign of the cross in prayer.</li> </ul>
1.2 The Trinity in the Bible	<ul> <li>How the Trinity is shown at the Baptism of Jesus (Matthew 3:13–17):</li> <li>God's voice from heaven</li> <li>the Holy Spirit descending like a dove</li> <li>Jesus being physically present.</li> </ul>
1.3 Creation	<ul> <li>The Biblical accounts of Creation (Genesis 1–3):</li> <li>that Creation took place over six days, followed by a day of rest</li> <li>the creation of Adam and Eve</li> <li>the first sin and the Fall of Adam and Eve.</li> <li>How this can be understood by Catholics today:</li> <li>as a literal (true) story</li> <li>as a way of understanding that the world was created by an all-powerful God (a symbolic story).</li> </ul>
	<ul> <li>What the Creation accounts can teach Catholics about God:</li> <li>God is the Creator</li> <li>God is loving (benevolent) as he made it good</li> <li>God as all powerful (omnipotent) as he created the world from nothing</li> <li>God has always existed and will always exist.</li> </ul>

Sub-topic	Students need to know and understand:
1.4 The importance of creation	<ul> <li>The idea that humans are created in the image of God (with reference to Genesis 1–3) and that they:</li> <li>are intelligent</li> <li>have freedom to choose between right and wrong</li> </ul>
	<ul> <li>have a relationship with God</li> <li>are able to demonstrate some of God's qualities, such as love.</li> <li>Different understandings of humanity's relationship with creation: <ul> <li>dominion (control of the world)</li> <li>stewardship (a responsibility to care for the world).</li> </ul> </li> <li>How Catholics can be good stewards: <ul> <li>care for the natural world, such as animals and environment</li> <li>recycling</li> </ul> </li> </ul>
	<ul><li> action against climate change</li><li> supporting CAFOD and other charities.</li></ul>
1.5 The Incarnation	<ul><li>What is meant by the Incarnation:</li><li>God became a human being</li><li>God's physical presence in the world.</li></ul>
	<ul> <li>How Jesus is described in John 1:1–18:</li> <li>as the 'Divine Word' (God's Word or message)</li> <li>as the 'Incarnate Son' (fully God and fully human).</li> <li>How the Bible presents Jesus as both fully God and fully human:</li> <li>being able to do Godly things such as miracles</li> <li>human as he gets tired, hungry and even angry.</li> </ul>
1.6 The Paschal Mystery	<ul> <li>Catholic teachings about the life, death, resurrection and ascension of Jesus (Luke 24):</li> <li>his life shows us how to live a good and holy life</li> <li>his death was proof of God's love for the world</li> <li>his resurrection shows that he was fully God</li> <li>his ascension shows that he is seated at the right hand of the Father</li> <li>his life, death, resurrection and ascension save us from sin.</li> </ul>
1.7 The importance of Jesus	<ul> <li>How the life, death, resurrection and ascension of Jesus links to the Catholic beliefs about salvation and grace (John 3:10–21 and Acts 4:8–12):</li> <li>through following Jesus's example, Catholics believe they can renew their relationship with God, who loves them and forgives them</li> <li>Catholics are shown a special type of love from God (Grace)</li> <li>through God's grace, Catholics believe they can join with him after death in heaven.</li> </ul>
	<ul> <li>The importance of grace and salvation for Catholics today:</li> <li>it reminds them that they are loved and can be saved by having a relationship with God.</li> </ul>

Sub-topic	Students need to know and understand:
1.8 Life after death	<ul> <li>Catholic beliefs about life after death:</li> <li>Catholics believe that there is life after death because Jesus rose from the dead and because of the promise he made.</li> </ul>
	<ul> <li>What is understood by Catholics by resurrection, judgement, heaven, hell and purgatory (John 11:17–27 and 2 Corinthians 5:1–10):</li> <li>resurrection – a physical return to life, like Jesus</li> <li>judgement – going to heaven, hell or purgatory because of the choices a person has made in life</li> <li>heaven – an eternal life with God</li> <li>hell – an eternal life away from God for those who reject God</li> <li>purgatory – a preparation for heaven for those who are not ready.</li> <li>Other Christian beliefs about life after death:</li> <li>some Christians believe it is only a spiritual afterlife</li> <li>some do not believe in purgatory, only heaven and hell.</li> <li>Reasons why belief in life after death is important for Catholics today:</li> <li>they want to be with God in heaven</li> <li>it gives them comfort in times of grief and illness.</li> </ul>

nature of reality	<ul> <li>through the whole of creation, humanity can experience the presence of God</li> </ul>
Ś	<ul> <li>the symbols involved in sacraments remind people of God's presence through all of creation</li> </ul>
	• this particularly includes bread, wine, water and oil.
	The seven sacraments are a meeting point with God:
	<ul> <li>baptism – washes away original sin and welcomes you into the Church as a Christian – through the use of water and oil</li> </ul>
	<ul> <li>confirmation – provides the Gifts of the Holy Spirit– through the use of oil and laying of hands</li> </ul>
	<ul> <li>Eucharist (Mass) – God gives himself as food as the body and blood of Jesus in Holy Communion – through use of bread and wine</li> </ul>
	<ul> <li>reconciliation (confession) – seeking forgiveness – through prayer</li> </ul>
	<ul> <li>anointing of the sick – giving strength and comfort in sickness – through the use of oil</li> </ul>
	<ul> <li>marriage – getting married in the Church – through making vows and giving of a wedding ring</li> </ul>
	<ul> <li>holy orders – becoming a deacon, priest or bishop – through the use of oil and special clothing.</li> </ul>
	Different Christian attitudes to sacraments:
	<ul> <li>most other Christians have only two sacraments – baptism and Eucharist.</li> </ul>
2.2 The Catholic	What happens at the Catholic Mass/Eucharist:
Mass	<ul> <li>Introductory Rite: the people gather, the priest welcomes them and they ask for forgiveness</li> </ul>
	<ul> <li>Liturgy of the Word: readings from the Bible, including from the Gospel</li> <li>Liturgy of the Eucharist: the priest prays for the Holy Spirit to transform</li> </ul>
	the bread and wine into the Body and Blood of Jesus, which people then receive in Holy Communion
	<ul> <li>Concluding Rite: the people are blessed and sent into the world to share the good news and carry out God's mission.</li> </ul>
	Reasons why the Mass/Eucharist is important:
	<ul> <li>it is the 'source and summit of Christian life'</li> </ul>
	<ul> <li>it strengthens faith by receiving Jesus in a physical way</li> </ul>
	<ul> <li>it makes the Last Supper, crucifixion and resurrection present for Catholics now</li> </ul>
	<ul> <li>it brings Catholics together, which is a source of strength.</li> </ul>
	Different Christian attitudes:
	<ul> <li>some other Christians have less formal worship where there is not a set order or way of doing things</li> </ul>
	<ul> <li>the Bible is usually still central in all Christian worship.</li> </ul>

Sub-topic	Students need to know and understand:
2.3 The funeral rite	<ul> <li>What happens at the funeral rite:</li> <li>at the church – the main funeral</li> <li>at the cemetery – the farewell at the cemetery or crematorium.</li> <li>The aims of the funeral rite:</li> <li>to pray for the person who has died</li> <li>to support the family through their journey through grief</li> </ul>
	<ul> <li>to bring together the Catholic community in prayer</li> <li>to remind everyone about belief in eternal life.</li> </ul>
2.4 Prayer	<ul> <li>Reasons why prayer is important:</li> <li>it allows you to open your heart and talk to God</li> <li>it allows you to hear from God.</li> </ul>
	<ul> <li>Different types of prayer:</li> <li>praising God (adoration), thanking God (thanksgiving), asking forgiveness (repentance), asking for others (intercession), asking for yourself (petition)</li> <li>set (formulaic) prayers: the Lord's Prayer, Hail Mary, the Creed</li> <li>informal prayer: prayer using your own words.</li> </ul>
2.5 Popular piety	<ul> <li>What popular piety means and its role in the Catholic Church:</li> <li>it refers to people showing their faith through religious actions</li> <li>popular piety does not replace Mass but adds to it.</li> </ul>
	<ul> <li>Forms of popular piety:</li> <li>the Rosary – beads are often used to say sets of one Lord's Prayer, ten Hail Marys and a Glory Be</li> <li>Eucharistic Adoration – praying in front of the Blessed Sacrament (Consecrated Host)</li> <li>the Stations of the Cross – praying at 14 images that show the suffering and death of Jesus.</li> </ul>
2.6 Pilgrimage	<ul> <li>Purposes of pilgrimage: <ul> <li>to visit the origins of Christianity</li> <li>to visit a place connected to a saint</li> <li>to take time out of everyday life and pray.</li> </ul> </li> <li>Key places of pilgrimage and why people go there: <ul> <li>Jerusalem – where Jesus died and was resurrected</li> <li>Lourdes – where Mary appeared to St Bernadette and healing miracles have happened</li> <li>Rome – the centre of the Catholic Church, where the Pope lives and where St Peter (the first Pope) died.</li> </ul> </li> </ul>

Sub-topic	Students need to know and understand:
2.7 Catholic social teaching	<ul> <li>Catholic social teaching:</li> <li>justice – making the world a fairer place</li> <li>peace and reconciliation – preventing war and resolving conflict</li> <li>Catholics will love and help those in need – for example through charity, donations, volunteering.</li> </ul>
	<ul> <li>Biblical basis for Catholic social teaching:</li> <li>the Good Samaritan – teaches people to always love their neighbour</li> <li>the Parable of the Sheep and Goats – teaching people that when they help the poor, they are taking care of Jesus and will be rewarded.</li> </ul>
	<ul> <li>The work of CAFOD:</li> <li>praying for peace and those living in poverty</li> <li>raising money for emergency and long-term aid</li> <li>educating people about the difficulties for many people around the world.</li> </ul>
2.8 Catholic mission and evangelism	<ul> <li>The history of mission and evangelism:</li> <li>the disciples were told at the Great Commission to baptise and spread the word of the Good News</li> <li>many Catholics have travelled the world spreading Christianity</li> <li>Catholics can spread the Good News in their everyday lives, including in their jobs, and to their friends and family.</li> </ul>
	<ul> <li>How mission and evangelism are put into practice by the Church:</li> <li>mission – living as a good example and copying the example of Jesus</li> <li>evangelism – spreading Christianity by helping others to find God.</li> </ul>

# Content

Sub-topic	Students need to know and understand:
1.1 The Bible	<ul> <li>The Bible is a collection of books in two main parts:</li> <li>the Old Testament – the story of the Israelites</li> <li>the New Testament – the story of Jesus and the early Church.</li> </ul>
	<ul> <li>The types of books in the Bible:</li> <li>Old Testament: Law, History, Prophets (messages from God), Writings (poetry and wisdom/advice)</li> <li>New Testament: Gospels (stories of Jesus), Letters (to early church communities), the Acts (the story of the early Church).</li> </ul>
1.2 Interpreting the Bible	<ul> <li>Different Christian communities understand the Bible in contrasting ways:</li> <li>inspired by God – God guided humans to write the Bible</li> <li>the literal Word of God – God dictated the Bible and the human authors had no impact on it.</li> </ul>
	<ul> <li>Meaning for Catholics:</li> <li>Catholics believe that people were inspired by the Holy Spirit to write the word of God in the Bible</li> <li>Catholics believe that the Bible messages contain truth</li> <li>some of the stories should not be taken literally; it is the message behind the stories that is more important</li> <li>Catholics believe that as the Bible is inspired by God, it guides people on how to live</li> <li>some parts of the Bible are not always clear, and the Church helps people to understand what it means.</li> </ul>

Section 1: Sources of wisdom and authority

Sub-topic	Students need to know and understand:
1.3 The authority of the Church	<ul> <li>Church leadership:</li> <li>the priest leads his parish</li> <li>the bishop leads his diocese</li> <li>the Pope leads the worldwide Church.</li> <li>How the Church leads and teaches:</li> <li>sayings and writings of bishops and popes</li> <li>by organising meetings called councils</li> <li>by the Pope making declarations.</li> <li>Importance for today:</li> </ul>
1.4 The Second Vatican Council	<ul> <li>bishops and the Pope have authority (power) to continue teaching Catholics, especially about issues not covered in the Bible.</li> <li>The Second Vatican Council was a very large meeting (council) in Rome:</li> <li>it took place from 1962 to 1965</li> <li>it aimed to 'throw open the windows of the Church'.</li> </ul>
1.5 The Church	<ul> <li>There were some important changes in churches as a result:</li> <li>Mass could be said in local languages instead of Latin</li> <li>the liturgy was re-written to help lay people be more involved in it</li> <li>the priest faced the congregation for Mass.</li> <li>How the Church is the Body of Christ:</li> </ul>
as the Body of Christ and the People of God	<ul> <li>the Church is living, like a body is</li> <li>Jesus is the head – he leads the way</li> <li>the Church needs its head to survive, like a body does</li> <li>Catholics are the Body of Christ on earth – they carry on the work of Jesus, working together like different parts of a body.</li> <li>How the Church is the People of God:</li> <li>when someone is baptised, they become part of the People of God.</li> </ul>
	<ul> <li>Different ways to do this:</li> <li>the laity – ordinary people helping in their parish and living good lives in the world</li> <li>the clergy – as priests</li> <li>the religious – as monks, nuns, and religious brothers and sisters.</li> </ul>
1.6 The four marks of the Church	<ul> <li>The Church is:</li> <li>One – there is one Church all united as Christians</li> <li>Holy – it is the Body of Christ with Jesus as the head</li> <li>Catholic – worldwide (universal)</li> <li>Apostolic – following the apostles of Jesus.</li> <li>Importance for Catholics today:</li> <li>to unite all the different Christians around the world</li> </ul>
	<ul> <li>to unite all the different Christians around the world</li> <li>to remind Catholics of the history and connection to all Christians.</li> </ul>

Sub-topic	Students need to know and understand:
1.7 Mary as a model of the Church	<ul> <li>Mary as a model of the Church:</li> <li>she was open to the Holy Spirit – when she agreed to be the mother of God's son</li> <li>she was joined with Jesus – as his mother on earth</li> <li>as a disciple – she believed in Jesus from his conception</li> <li>she showed faith and charity – she accepted God's message and looked after Jesus.</li> </ul>
	<ul> <li>How this is seen in Mary's role in the Catholic Church today:</li> <li>statues of Mary are common in churches, schools, and homes</li> <li>important titles given to Mary – Our Lady, Madonna, Blessed Mother</li> <li>there are many feast days, hymns and prayers for Mary.</li> </ul>
1.8 Making ethical decisions	<ul> <li>Catholics, like all people, need to make decisions about how they behave and react in situations. They often look to Jesus as teacher: <ul> <li>he showed great love – he helped the poor and healed the sick</li> <li>he showed forgiveness in word and action – he even forgave those who crucified him</li> <li>he was a servant – he washed the feet of his disciples before the Last Supper</li> <li>he didn't abolish Jewish law – he showed a new way to understand it.</li> </ul> </li> <li>How Catholics can use Jesus and the Bible as guidance when making decisions: <ul> <li>they follow the example of Jesus</li> <li>they use the Bible and examples from the history of the Church</li> <li>they use the Bible to inform their conscience and to help them do good (natural law).</li> </ul> </li> </ul>

Sub-topic	Students need to know and understand:
2.1 Catholic church architecture	<ul> <li>Architecture means the design of the building:</li> <li>a church is a building where Catholics worship</li> <li>the design supports Catholics in worship.</li> </ul>
	<ul> <li>How the design of churches reflects belief:</li> <li>churches usually face east – this is because Jerusalem is in the east and the rising sun reminds people of the resurrection</li> <li>churches are often shaped like a cross – this reminds people of the crucifixion</li> <li>churches often have high ceilings that reach up towards heaven</li> <li>churches often have stained glass windows to tell stories from the Bible</li> <li>the container of holy water at the entrance of the church contains Holy water – this reminds people of baptism.</li> </ul>
2.2 Features of a Catholic church	<ul> <li>The following items are found in most Catholic churches:</li> <li>the lectern – where the Bible is read from</li> <li>the altar – where the bread and wine are turned into the body and blood of Christ</li> <li>the crucifix – representing Jesus on the cross</li> <li>the tabernacle – where the Eucharist (consecrated host) is kept</li> <li>the baptismal font – where people are baptised.</li> </ul>
2.3 Sacred objects	<ul> <li>Sacred objects and sacred vessels are used during the Mass:</li> <li>the chalice (cup) for the wine/blood of Christ</li> <li>the paten (plate) for the larger bread/body of Christ</li> <li>the ciborium (covered dish) for the rest of the bread/body of Christ.</li> <li>Other items: <ul> <li>hunger cloths – these were used during Lent to help tell stories from the Bible.</li> </ul> </li> </ul>
2.4 Artwork in Catholicism	<ul> <li>Artwork has always played an important role in Catholicism:</li> <li>to help people understand key religious messages</li> <li>to remind people of key events and beliefs.</li> <li>to express the artist's belief and use a talent that God has given.</li> <li>Types of artwork include:</li> <li>paintings – usually telling stories from the Bible</li> <li>mosaics – made from small tiles and often showing a saint or angel</li> <li>frescoes – painted murals on plaster</li> <li>drawings – often personal reflections on a religious theme.</li> </ul>
2.5 Sculpture and statues	<ul> <li>Catholics use sculpture and statues to remember the person or event shown. They can support worship by acting as a focus for prayer:</li> <li>praying before them</li> <li>kneeling in front of them</li> <li>touching or kissing them</li> <li>lighting candles in front of them</li> <li>reminding them of the life of a saint or particular pilgrimage.</li> <li>This is why they are often seen in churches and homes for private prayer.</li> </ul>

# Section 2: Forms of expression and ways of life

2.6 Symbolism	A symbol is an object or image that is used to represent something else.

This helps their relationship with God.</li> </ul>			
2.4 The Shema and Amidah	<ul> <li>Two of the most important Jewish prayers are the Shema and Amidah:</li> <li>The Shema: <ul> <li>is the most important Jewish prayer</li> <li>is prayed twice or three times a day</li> <li>declares that God is the one God</li> <li>is found in the Mezuzah, which is on the doorframe in Jewish houses and other buildings.</li> </ul> </li> <li>The Amidah: <ul> <li>is the key part of any worship in the synagogue</li> <li>is said standing up (and so is often called 'the standing prayer').</li> </ul> </li> </ul>

2.6 Shabbat	<ul> <li>Shabbat is the special day of rest:</li> <li>God instructed a day of rest which should be kept holy to remember the seventh day of Creation when God rested</li> <li>it begins at dusk on Friday and ends when stars appear in the sky on Saturday evening.</li> </ul>
	<ul> <li>At home:</li> <li>the home is prepared for a special meal that has to be cooked before Shabbat begins</li> <li>all work is forbidden and the Torah lists 39 different actions which should not take place.</li> </ul>

2.7 Festivals	<ul> <li>Festivals are important as they help connect Jews to their history and identity, and are also a chance to be together with family and friends:</li> <li>Rosh Hashanah – the Jewish New Year celebrating the anniversary of creation, when Jews ask forgiveness from God and one another</li> <li>Yom Kippur – this is 10 days after Rosh Hashanah and is the 'Day of Atonement' when Jews ask forgiveness for their sins</li> <li>Pesach (Passover) – this remembers the escape from slavery in Egypt; a meal is eaten with some symbolic foods and the story of the Exodus is read out</li> <li>Shavuot – this is the celebration of the law being given to Moses on Mount Sinai; it is 49 days after Pesach</li> <li>Sukkot – this is the harvest festival 4 days after Yom Kippur and remembers the Tabernacle in the wilderness.</li> </ul>
2.8 Features of a synagogue	<ul> <li>The features of a synagogue help remind Jews of what is important in their faith:</li> <li>the synagogue normally faces towards Jerusalem – if not, the congregation will stand and face Jerusalem when praying</li> <li>the Ark – this is where the Torah scrolls are kept and is found on the wall facing Jerusalem</li> <li>ner tamid – this light is kept burning at all times in front or above the Ark as a reminder of God's eternal presence</li> <li>the menorah – this holds 7 candles</li> <li>the bimah – this is the reading platform where the rabbi leads the service, and the Torah is read from.</li> </ul>
	<ul> <li>There are some differences in synagogues:</li> <li>men and women may be separate in an Orthodox synagogue</li> <li>musical instruments may be used in Reform or Liberal synagogues</li> <li>women can take an active part in some Reform or Liberal synagogues.</li> </ul>

# Content

1.8 Solutions to the problem of suffering	<ul> <li>If any of the above is true, then it questions God's nature.</li> <li>The Church teaches that there are solutions to the problem of suffering: <ul> <li>in the Bible, there are people who suffered but trusted God, including the story of Job in the Old Testament</li> <li>for St Augustine, suffering exists because humans misuse the gift of free will</li> <li>for St Irenaeus, suffering exists because it helps humans grow in goodness.</li> </ul> </li> </ul>
	<ul> <li>There are also practical responses for Catholics:</li> <li>prayer – they can share their suffering and ask for help for those need</li> <li>charity – they can actively help and contribute through money or their time to those in need.</li> </ul>

### Section 2: Catholic Teachings on Relationships and Families

Sub-topic	Students need to know and understand:
2.5 Family planning	<ul> <li>The Church's teaching on family planning is that:</li> <li>artificial contraception is wrong as it stops the marriage being open to having children, which is God's will – this includes condoms and the contraceptive pill</li> <li>natural family planning is acceptable – this involves working out when a woman is more and less fertile during her menstrual cycle.</li> <li>Non-Catholics, including other Christians, may not see any issues with artificial contraception.</li> </ul>
2.6 Divorce, annulment and remarriage	<ul> <li>The Church teaches that sacramental marriage is a lifelong commitment:</li> <li>a legal divorce is possible, but the couple remain married in the eyes of God and cannot remarry in the Church; no human can break the bonds of a sacramental marriage</li> <li>an annulment means that for some reason the marriage was not valid and did not exist; so these individuals can get married in the Church afterwards.</li> <li>Non-Catholics, including other Christians, may not see any issues with</li> </ul>
2.7 Equality of men and women in the family	<ul> <li>divorce or remarriage.</li> <li>The Church teaches that women and men should have equal roles and rights in the family.</li> <li>domestic work is of great value and can be done by either a man or woman and is no less valuable than work which produces money</li> <li>both the wife and husband are called to 'give themselves' in commitment to make their marriage work and create a home for children</li> <li>Pope Francis stated that the role of women in the family is indispensable.</li> <li>Equal roles and rights for men and women is important to most Christians, and this reflects wider society.</li> </ul>
2.8 Equality of men and women outside the family	<ul> <li>The Church opposes gender-based prejudice and discrimination because both men and women are 'one in Christ':</li> <li>the Bible says that man and woman were created in the image and likeness of God</li> <li>there are examples of Jesus treating women with kindness and respect: <ul> <li>the Samaritan woman at the well</li> <li>the woman accused of adultery</li> <li>he taught that women had a right to hear the Gospel</li> <li>he had friendships with women followers such as Martha and Mary.</li> </ul> </li> <li>Men and women can play different roles in the Church: <ul> <li>the Catholic Church does not have women priests as Jesus chose only men to be present at the Last Supper</li> <li>however, there are other roles for women's service and ministry, for example as catechists, readers, Ministers of Holy Communion.</li> </ul> </li> <li>Other Christian Churches, such as the Church of England, do have women priests and bishops.</li> </ul>

# Assessment information

#### Tests

- Centres must ensure that they are using the live tests, not the sample tests.
- Each test is worth 20 marks, and students must answer all questions. Questions may include a variety of question types, for example matching, ordering, true/false, multiple-choice, sentence gap fills and short-open response questions.
- Each test can be taken whenever students are ready.
- There is no set time limit for how long students can take to complete each test.
- The tests can be taken in classroom conditions, but other examination procedures apply, regarding the need for safeguards against communication between students. Students are not permitted to access other materials, for example notes or books.
- Teachers can help students to understand what a question is asking, but must **not** help them to answer.

#### Retakes

- Students can retake the tests if needed. However, no feedback or guidance on their original answers should be provided. This means that the completed tests cannot be given back to students.
- There must be a gap of at least two weeks before they can retake the tests.

#### **Master copies**

- Centres will be able to download a clean master copy of each test and mark scheme from the Pearson website pages for the qualification. Teachers will need to photocopy the master copies of the tests for students to complete.
- Master copies must be kept confidential and under secure conditions at all times.
- The tests and mark schemes will remain valid for the lifetime of the qualification.

#### Marking and moderation

- The tests are marked by the centre using the published mark scheme and moderated by Pearson.
- Any unused tests must be returned to secure storage or disposed of securely.

# Access arrangements, reasonable adjustments, special consideration and malpractice

Equality and fairness are central to our work. Our equality policy requires all students to have equal opportunity to access our qualifications and assessments, and our qualifications to be awarded in a way that is fair to every student.

#### Language of assessment

Assessment of this qualification will be available in English. All student work must be in English.

# Access arrangements

Access arrangements are agreed before an assessment. They allow students with special educational needs, disabilities or temporary injuries to:

- access the assessment
- show what they know and can do without changing the demands of the assessment.

The intention behind an access arrangement is to meet the particular needs of an individual student with a disability, without affecting the integrity of the assessment. Access arrangements are the principal way in which awarding bodies comply with the duty under the Equality Act 2010 to make 'reasonable adjustments'.

Access arrangements should always be processed at the start of the course. Students will then know what is available and have the access arrangement(s) in place for assessment.

## Reasonable adjustments

The Equality Act 2010 requires an awarding organisation to make reasonable adjustments where a person with a disability would be at a substantial disadvantage in undertaking an assessment. The awarding organisation is required to take reasonable steps to overcome that disadvantage.

A reasonable adjustment for a particular person may be unique to that individual and therefore might not be in the list of available access arrangements.

Whether an adjustment will be considered reasonable will depend on a number of factors, including:

- the needs of the student with the disability
- the effectiveness of the adjustment
- the cost of the adjustment; and
- the likely impact of the adjustment on the student with the disability and other students.

An adjustment will not be approved if it involves unreasonable costs to the awarding organisation, or affects timeframes or the security or integrity of the assessment. This is because the adjustment is not 'reasonable'.

# Special consideration

Special consideration is a post-examination adjustment to a student's mark or grade to reflect temporary injury, illness or other indisposition at the time of the examination/ assessment, which has had, or is reasonably likely to have had, a material effect on a candidate's ability to take an assessment or demonstrate their level of attainment in an assessment.

# Malpractice

### **Candidate malpractice**
