### **Indicative content guidance**

Answers must be credited according to candidates' deployment of material in relation to the qualities outlined in the mark scheme. While specific references are made in the indicative content below, this does not imply that these must be included; other relevant material must also be credited.

Relevant points may include:

- The Puritans were unhappy about the special vestments that priests were expected to wear, believing them to be too close to Catholic vestments.
- The Act of Uniformity prevented Puritans from choosing their own form of worship, forcing them to challenge the settlement in areas where they disagreed with it.
- The Puritans challenged aspects of church decoration set out in the religious settlement, for example crucifixes and altars, because they believed churches should be plain and simple.
- The Puritans did not like the new prayer book, which was deliberately vague around controversial aspects such as transubstantiation, with which the Puritans disagreed.
- The Puritans did not support the existence of bishops within the Church hierarchy put in place by the religious settlement, leading them to challenge it.
- Many Puritans had left England during the reign of Mary I and, after living in mainland Europe where there was more tolerance for their beliefs, on their return, wanted a more radical settlement.

Relevant points which support the statement may include:

- Mary was vocal in her claims to the English throne and did not recognise Elizabeth as the legitimate monarch.
- Many English Catholics saw Mary as the legitimate queen of England as they did not recognise Henry's marriage to Elizabeth's mother, Anne Boleyn.
- Elizabeth was unmarried and childless: Mary was next in line to the throne and had a son, and therefore posed a potential threat to Elizabeth.

Relevant points which counter the statement may include:

- Plots, such as the Ridolfi, Throckmorton and Babington plots, demonstrated that Mary would continue to be a focus for Catholic rebellion while she remained alive, leading to ongoing tension.
- Mary's Catholicism made her an attractive alternative monarch in the eyes of Spain; the Ridolfi and Babington plots were supported by Spain and some funds were supplied to Throckmorton.
- Mary's Catholicism and previous alliance with France increased the threat of a French invasion in support of her, which threatened the stability of Elizabeth's kingdom.
- The Northern Earls staged a rebellion (1569) centred around Mary, aiming to depose Elizabeth and crown Mary, raising tension between the two monarchs.
- Mary's physical presence in England meant that Elizabeth had to keep her imprisoned, as Mary could potentially have raised an army to depose Elizabeth.

Relevant points which support the statement may include:

- There was little change in the provision of schooling for girls.
- The rate of literacy among women remained roughly the same throughout the period.
- Since the majority of the population were labourers, they could not afford to send their children to school and therefore education did not change for most children.
- Attendance at school remained optional, which meant that parents kept their children at home if they were needed.

Relevant points which counter the statement may include:

- More schools, known as petty schools, were set up, increasing the availability of education for young children.
- Over 70 new grammar schools were founded in this time period, increasing the availability of grammar school places.
- Attendance at university increased.
- The influence of humanism meant that the curriculum expanded to include ancient philosophers.
