Assessment Objective:

Understand and respond to spoken language (AO1)

Section A

Question 1:

Specification Topic: Gönüllü kuruluşlar

Feature - with reasons: Most of the candidates' knowledge of vocabulary was good. They managed to fill out the lines correctly.

Question 2:

Specification Topic: Sosyal Yaşam

Feature - with reasons: This question was answered correctly by most of the candidates. Perhaps some candidates did not have time to write 'kültürel etkinlik' and wrote only (kültürel), however they still got one mark because kültürel was the key word.

Question 3:

Specification Topic: A school Trip

Feature - with reasons: This question was answered by most of the candidates. Common mistake was (iv) fresh/delicious.

Question 4:

Specification Topic: Weather

Feature - with reasons: This year the candidates were successful in answering this question. However, some ticked more than three boxes and lost marks.

Question 5:

Specification topic: My school

Feature - with reasons: Most of the candidates were awarded full marks for this question. However, the common mistakes were (i) hardworking and (iii) reading.

Question 6:

Specification topic: Shopping on holiday

Feature - with reasons: Most of the candidates answered this question correctly. The topic was interesting for the candidates.

(a) Some candidates managed to identify why the place has historical value by mentioning the Ottoman Empire.

(b). This question was challenging for many candidates. They found it hard to mention the names of the two cities. However, some managed to mention the importance of the road in terms of trading.

(c) and (d) were answered correctly by many candidates.

Question 7

Specification Topic: Eurovision song contest

Feature - with reasons:

- (a) Most of the candidates gave Sweden as an answer and lost marks.
- (b) The candidates answered this question in different ways such as ‘to establish a cultural bond’, to get to know different cultures’ and were awarded full marks.
- (c) Nearly most candidates answered this question correctly.
- (d) Many candidates were not successful in writing the numbers correctly.
- (e) Most of the candidates answered this question correctly.
The candidates need to revise the names of the countries and the numbers.

Question 8:

Specification Topic: Being green

Feature - with reasons: This question was answered correctly by most of the candidates correctly.

Question 9:

Specification Topic: Jobs

Feature - with reasons: This question was attempted by most of the candidates.

- (a) (i) Some candidates answered only one part of the question and awarded only one mark.
- (ii) This was answered by nearly all candidates.
- (iii) Those who did not know the word ‘applicant, interviewer or interviewee did not understand the question and gave an answer as ‘This easy question would give time to interviewer to prepare questions’ and lost marks.
- (iv) and (v) These questions were answered by many candidates correctly.

9 (b) (i) This question was answered correctly only by some candidates. Some candidates wrote what they would say if they were the applicants.

- (ii) Most of the candidates answered these questions correctly.

Question 10:

Specification Topic: Social media

Feature - with reasons: The topic was relevant to most of the candidates. Most candidates answered this question correctly.
