Candidates will be required to demonstrate thorough knowledge and understanding as well as accuracy of religion and belief when responding to the question and in meeting AO2 descriptors.</p> <p>AO2</p> <p>Arguments for the statement:</p> <ul style="list-style-type: none"> • The main teaching of Sikhism is equality, through the Guru Granth Sahib all Sikhs are reminded that 'All beings and creatures are His. He belongs to all.' (Guru Granth Sahib 425) • Guru Nanak taught that women and men are both equal and respected. One of his teachings that reflects this is 'From woman, man is born' therefore 'without woman, there would be no one at all.' (Guru Granth Sahib 473) • Mai Bhago is an excellent example of how women were treated equally. She was given the task of leading 40 Sikh soldiers to battle and was one of Guru Gobind Singh's bodyguards. This shows that women were just as capable as men in war. <p>Arguments against the statement:</p> <ul style="list-style-type: none"> • Some Sikhs may disagree with this statement as culturally they are treated differently, for example, women are not allowed to read from the Guru Granth Sahib at the Harmandir Sahib • In some areas women are still expected to stay at home and look after the family. Girls are expected to do most of the household chores • Some Sikh females have experienced discrimination within the family and at the gurdwara. Candidates will be required to demonstrate thorough knowledge and understanding as well as accuracy of religion and belief when responding to the question and in meeting AO2 descriptors.</p> <p>AO2</p> <p>Arguments for the statement:</p> <ul style="list-style-type: none"> • Sikhs believe that suffering is part of God’s plan and is connected to their karma, therefore a Sikh will have to accept God’s will. Therefore, suffering cannot be avoided • Some Sikhs believe that suffering is part of being manmukh and part of human life. Therefore, it cannot be prevented as humans choose to do evil • Non-religious people believe suffering will always exist as nature causes suffering and can be classed as evil. We cannot prevent natural disasters, so there is no solution. <p>Arguments against the statement:</p> <ul style="list-style-type: none"> • Sikhs believe suffering happens. God does not cause suffering but permits it as a test of faith. A solution to this is by understanding and being satisfied with God’s will • Suffering is caused by Sikhs’ actions by not following the five virtues and not leading a gurmukh life. If all people did follow them, it would help to prevent all suffering • ‘If a mind becomes a stranger to God, then all the world becomes a stranger to him’ (Guru Granth Sahib 767). This teaches Sikhs that if Sikhs do not follow religious teachings, you become detached. Candidates will be required to demonstrate thorough knowledge and understanding as well as accuracy of religion and belief when responding to the question and in meeting AO2 descriptors.</p> <p>AO2</p> <p>Arguments for this statement:</p> <ul style="list-style-type: none"> • True worship is to keep God in one’s mind, so Nam Japna is the most important form of worship as the Guru Granth teaches ‘Worship and adore Him, and you shall be at peace forever’ (Guru Granth Sahib 896) • Calling to mind the name of God is vital to Sikh worship. It helps a Sikh concentrate their mind on God and avoid distractions that could be harmful to their spiritual growth • Sikhs believe that meditating on God’s name helps them focus on what is important in life (The True Lord), to become God-centred and help them avoid the five evils ‘Worship in adoration that True Lord; everything is under His Power.’ (Guru Granth Sahib 521). <p>Arguments against this statement:</p> <ul style="list-style-type: none"> • Worship for Sikhs is a way of life and it is up to the individual how they worship. Some Sikhs may believe that worship in the gurdwara and listening to the Guru Granth Sahib being read can give them focus and be just as important • Selfless service in the langar is another form of worship that is encouraged. It helps Sikhs focus on others and serving God, not just in their community but in the gurdwara • Celebrating gurburbs in the gurdwara can give Sikhs access to God ‘At the Gurdwara, the Guru’s Gate, the Kirtan of the Lord’s Praises are sung.
