

# Summary of use of reader/scribe/word processor for 9-1 International GCSE in English Language, specifications A and B, and English Literature

This is a complicated area, with different options available. For full details, please see JCQ's <u>access document</u>. **The rules for GCSE apply** equally to International GCSEs.

The main principle is that students are rewarded for the aspects of the quality of written communication that they are responsible for. There are not a discrete number of marks which are deducted when a scribe (human or `technological') is used.

Mark schemes are applied using the 'best fit approach'. Where a student has used a scribe, the examiner will select a level of the mark scheme using the 'best fit approach' and then make an adjustment according to the information given on the scribe front sheet. There is no deduction of a discrete number of marks as a result of the use of a scribe.

This extract (p. 54) explains the position on the use of scribes:

'5.7.7 In subjects where quality of written communication (QWC) is being assessed or where the candidate's spelling, punctuation and grammar (SPaG) is specifically being assessed, a scribe will be allowed.

A scribe will be allowed in the written papers of the following GCSE subjects:

• GCSE English/GCSE English Language (including the Writing section); • GCSE English Literature; • GCSE Geography; • GCSE History; and • GCSE Religious Studies.

However, where a scribe is used in an examination assessing quality of written communication or spelling, punctuation and grammar, marks can only be awarded if the candidate can demonstrate that he/she has carried out the particular skills being assessed.'

Where a scribe is used, the scribe completing the scribe cover sheet specifies what the student has and has not done:

Centres **must** ensure that the correct scribe front sheet is fully filled in and that it is attached to the script, so that the examiner is aware of the conditions under which the paper was completed.

Students using a scribe must be made aware of the different options and how these affect their access to marks. In most cases, students will dictate punctuation but not spelling. A student wishing to be rewarded for their punctuation and the structuring of their text must be instructed to dictate punctuation and paragraphing to their scribe.

#### Use of a word processor

The use of a word processor (permitted where it is the student's usual way of working) with the spell check and grammar check disabled has no impact on marks for AO6. The same approach applies as with a scribe: a student is rewarded for the AO6 elements they have demonstrated (all elements [spell and grammar check disabled]/all elements except spelling [spell check enabled]/vocabulary range but not spelling or grammar [spell and grammar check enabled]).
