

English Literature: expanded choice of set text editions for Paper 2

We've listened to feedback from you and have given you a wider choice of editions of the set texts for Paper 2 open book exams.

The advantages:

- You can use editions you may already have in the stock cupboard instead of buying a new edition.
- You can purchase cheaper editions where available.
- You can make use of dyslexia-friendly editions where available so that students have a seamless study/assessment experience rather than having to sit exams with a different edition.
- In countries where it may be more challenging to source texts, there is more choice, hopefully making purchasing easier.

Resit rules for linear Int GCSEs

Resit rules

The next resit option is the November exam series, open to all candidates (first sitters and resitters).

4EA1/4ET1

Students have the option to sit Papers 1 and 2 (exam-only route), or 1 and 3 (coursework).

Resitting students on the exam-only route must resit both papers 1 and 2.

Resitting students who have sat Paper I and coursework, must resit Paper I. They have the option to either carry forward their coursework marks or submit new coursework. New coursework may be written on the same texts as in the previous attempt at the qualification, but a new title must be selected and new work submitted. After making the entry with the correct option code, the teacher/exams officer submits the student's marks and their coursework (if the student forms part of the requested sample).

If a student chooses to carry forward their coursework marks, after making the entry with the correct option code, the teacher/exams officer does not resubmit the student's marks or coursework to the moderator. The student's work will not be a part of the sample.

4EA1 cwk change: The total marks for the coursework is the same for both specifications and **the change in format does not affect the carry forward arrangements**. A student may carry forward coursework marks from a pre-May/June 2024 certification in subsequent exam series.

Coursework and AI challenges

Coursework remains significantly more popular than the exam:

4EA1:

Approx 40% exam: 60% coursework, with coursework significantly more popular with UK centres.

4ET1

Approx 30% exam: 70% coursework, with coursework significantly more popular with UK centres.

Teacher views on coursework versus exam

From the Facebook group:

- I would opt for coursework if I was given the opportunity. It gives students more flexibility, and I think it allows them to show their strengths better than in timed exams. All is a concern, but I'd manage that by having them draft in class and discuss their ideas with me regularly.
- Agree re the vigilance required because of AI. We now manage it like the old CAs. We have them plan in advance then they have a set number of lessons in which to do their write up. This has to be done under teacher supervision with Apple Classroom enabled so we can see which apps they've accessed. They then have time to redraft but again, it has to be under supervision. They must submit what's been done after each lesson so we can see where it's come from and there's much less chance of unexpected magical transformations! We've been considering going back to 100% exam, but that would put huge pressure on the students, so we've held off, for now!

Teacher views on coursework versus exam

From the Facebook group:

- In terms of administering you have to be really vigilant with Al monitoring we make the students
 plan in detail by hand first and then they have to submit that with the piece. We also (with some
 classes) get them to write a section with wifi access cut off then submit via google classroom for us
 to check and then repeat.
- I think the coursework dominates too much and you need very high marks to access good levels. It becomes a burden imo and we have achieved much better results by going to all examinations for both Lang and Lit if that helps. It's not worth the hassle.

Modular routes for international centres

A guide to modular results will be offered separately.

In September 2023, we introduced a modular version of 4EA1 and 4ET1 for first certification in August 2025 **for international centres only**.

The introduction of this option (which does not include coursework) does not affect the existing linear specifications 4EA1 and 4ET1. They will continue to be offered both in the UK and internationally in their current forms. **The availability of coursework for the linear Int GCSEs is completely unaffected.**

Apart from the mode of assessment and the absence of coursework on the modular specifications, the linear and modular specifications are identical in terms of course content.
