## General Marking Guidance

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme not according to their perception of where the grade boundaries may lie.
- There is no ceiling on achievement. All marks on the mark scheme should be used appropriately.
- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification may be limited.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, the team leader must be consulted.
- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.

## Placing a mark within a level mark band

- The instructions below tell you how to reward responses within a level. Follow these unless there is an instruction given within a level. However, where a level has specific guidance about how to place an answer within a level, **always** follow that guidance.
- **2 mark bands**  
Start with the presumption that the mark will be the higher of the two.  
An answer which is poorly supported gets the lower mark.
- **3 mark bands**  
Start with a presumption that the mark will be the middle of the three.  
An answer which is poorly supported gets the lower mark.  
An answer which is well supported gets the higher mark.
- **4 mark bands**  
Start with a presumption that the mark will be the upper middle mark of the four.  
An answer which is poorly supported gets a lower mark.  
An answer which is well supported and shows depth or breadth of coverage gets the higher mark.

3	<p><b>Explain how each of the following helped in the spread of Islam during the seventeenth and eighteenth centuries:</b></p> <ul style="list-style-type: none"> <li>• <b>Sheikh Ahmad Sirhindi</b></li> <li>• <b>Shah Wali Ullah</b></li> <li>• <b>Syed Ahmad Shaheed Barailvi</b></li> </ul> <p><b><u>Sheik Ahmad Sirhindi</u></b></p> <ul style="list-style-type: none"> <li>• Promoted Islam</li> <li>• Influence through Afghanistan, Central Asia and Ottoman Empire</li> <li>• Called Mujaddih-i-alf-i-thani (the one who restored pure doctrine to Islamic thought)</li> <li>• Pointed out difference between Islam and Hinduism</li> <li>• Against prostration - should only do it before God</li> <li>• Imprisoned at Gwalior Fort for 2 years by Jehangir who then realised his mistake and invited him to a special audience</li> <li>• Organised Naqshbandiya Mujadidiya Order for trying to reform society and to spread the Shariah amongst the people</li> <li>• Wrote books - Isbat-ul-Nabat and Risal-e-Naboowat</li> <li>• Greatest work was Tauheed-i-Shuhudi</li> </ul> <p><b><u>Shah Wali Ullah</u></b></p> <ul style="list-style-type: none"> <li>• Went to Arabia in 1724 and influenced by Ibrahim</li> <li>• Studied at Medina and returned to Delhi in 1732</li> <li>• Realised there was a need for moral regeneration through strong leadership</li> <li>• To be achieved by: an emphasis on Quranic teachings, Holy Quran translated into Persian, urges Muslims to concentrate on fundamental principles of Islam</li> <li>• A prolific writer - 51 books written including Hujjatallah-ul-Balighah and Izlat-ul-Akhfa</li> </ul> <p><b><u>Syed Ahmad Shaheed Barailvi</u></b></p> <ul style="list-style-type: none"> <li>• Wished to purify Muslim society and to remove the British from India</li> <li>• Armed struggle and confrontation against foreign and non-Muslim forces</li> <li>• Influences from Shah Wali Ullah and Shah Abdul Aziz</li> <li>• Wanted to establish a state built on Islamic principles</li> <li>• The Punjab was under Sikh rule which he wished to overthrow.
