Level 7 University Progression and Recognition

This document outlines universities and higher education institutions that have indicated they will consider one or more Pearson BTEC Level 7 qualification, specifically our Level 7 Strategic Management and Leadership (SM&L) for postgraduate study or credit exemption.

Please note: This is not an exhaustive list. Many other institutions worldwide may also accept BTEC Level 7 qualifications. Learners are strongly encouraged to research potential progression routes and contact universities directly before applying.

Important Considerations

- **Recognition versus Admission:** Recognition of a qualification does not guarantee admission. Learners must meet specific university entry requirements, which may include subject relevance, credit thresholds, and professional experience.

Qualification Sizes

Pearson offers three sizes of the Level 7 qualification:

- **Certificate (20 credits):** A short, focused introduction to strategic management and leadership.
- **Diploma (60 credits):** A broader programme covering strategic change, marketing, HR, and more.
- **Extended Diploma (120 credits):** A comprehensive postgraduate-level programme designed to prepare learners for senior leadership roles.
