3. Supporting your learners' progression with BTEC

We're working hard to ensure BTEC continues to meet the government's requirements for performance tables in England. And as the skills-gap debate continues, you can be confident BTEC will offer teachers high quality qualifications for learners at all levels.

In fact:

- In 2016, UCAS and HESA data confirmed that nearly 1 in 4 learners who got into university did so with a BTEC.
- A report from London Economics in 2013 indicated that 90% of BTEC learners are employed full-time after graduating.
