Notes

1. Submission of Examination Entries to Examination Centres

Candidates must check with their Examination Centres for the registration closing dates which at overseas Centres may well be earlier than the dates set by Pearson.

2. All centres must submit Examination Entries to Pearson no later than:

- April 2023 series – 6 March 2023
- September 2023 series – 25 July 2023

Entries for all series will open two weeks before the closing date.

Please note that late entries cannot be accepted for timetabled examinations due to the timescales required for print, despatch, and delivery of the papers.

3. Timetabled Dates

All timetabled examinations must take place on the dates shown. In centres where candidates are unable to sit an examination on the timetabled date the centre should create a new case record to request support from the Pearson Customer Support Team at
