

## **Funding Focus** 16-19 and 19+ funding information for 2015/16

Funding Focus provides quick summaries of recent funding developments, or particular aspects of the funding system. They are produced for internal and external colleagues.

All 174 of the BTEC QCF Nationals are approved by the Education Funding Agency (EFA) for 16-18 funding. 148 are approved by the Skills Funding Agency (SFA) for 19+ funding and loan funding. This table lists all the BTEC QCF Nationals, their eligibility for 19+ funding and loan funding, and the reason why, and highlights 23 gualifications newly eligible for 19+ funding and loan funding in 2015/16 in the notes column.

- 86 BTEC OCF Nationals are Level 3 Tech Level qualifications automatically approved for 19+ funding and loan funding.
- 54 BTEC QCF Nationals are Level 3 Applied General qualifications automatically approved for 19+ funding and loan funding.
- 8 BTEC QCF Nationals, not designated Level 3 Tech Level qualifications or Level 3 Applied General qualifications, are approved for 19+ funding and loan funding as we made successful submissions to the SFA.
- 26 BTEC QCF Nationals are not approved for 19+ funding and loan funding as we could not make a successful submission to the SFA.

## Further notes

- 23 of the 54 Level 3 Applied General qualifications, previously ineligible, are newly approved for 19+ funding and loan funding. (The SFA announced on the 24 September announced that Level 3 Applied General qualifications would be automatically approved for 19+ funding and loan funding.) 31 of the 54 Level 3 Applied General qualifications were already approved for 19+ funding and loan funding as we made successful submissions to the SFA.
