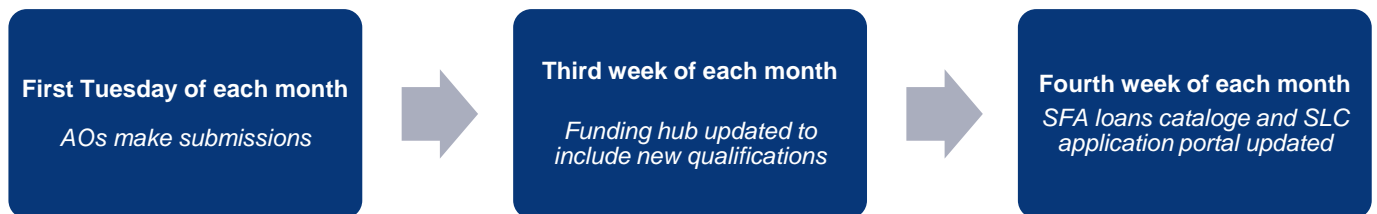

The submission process

The process is monthly:



Qualifications eligible for advanced learner loans

- QAA Access to HE Diplomas, GCE Advanced Level (A-level) and Advanced Subsidiary Level (AS-level) and Tech level and Applied general qualifications the (DfE) recognises in their 16-19 performance tables are automatically designated for the loans offer.
- Other qualifications can be added if they meet the SFA's criteria: it supports progression to and through higher-level technical and professional education and skills; direct entry to a specific job role; continuing professional development in an occupation; or upskilling or reskilling in an occupational area. Qualifications must be 150 GLH or 15 credits (though exceptions can be considered).
- Qualifications that are required by a licensing authority so an individual can operate in a regulated job role, or that provide training to meet employers' legislative responsibilities such as Health and Safety, First Aid and Food Safety, cannot be considered for loan funding.

The extension of the loan offer in 2016/17

- From 2016/17 the loans offer will be extended to **19-23** year-olds studying for a repeat level 3 or level 4 qualification (previously only available to 24+ year-olds), and for those aged 19 and over studying for a **level 5 or 6** qualification (previously only available for levels 3 and 4).
- Delivery to 19-23 learners, and delivery of level 5 and 6 qualifications, cannot begin until the start of the 2016/17 funding year. Applications for the expanded advanced learner loan can be made from May 2016 for courses starting from 1 August 2016.
