Funding News this week is mainly a reminder that the long-awaited key apprenticeship documents were published at the end of last week: proposals for apprenticeship funding, and a new register for apprenticeship providers, and further information on the levy, how much the levy will bring in, and an online calculator. We include links to our summaries of some of these documents and will bring you further summaries shortly. We also include a reminder that DfE has opened surveys on two of the documents: the proposals for apprenticeship funding, and the proposals for a new Register of Apprenticeship Training Providers. Both close on Monday 5 September.

Post-16 policy

Reminder: Sainsbury Review and Post-16 Skills Plan, plus a Pearson Handy Guide, and a Pearson Pocket Watch

On the 8th July BIS and the DfE published the long awaited [Sainsbury Review of technical and professional education in England](#), and, alongside it, the [Post-16 Skills Plan](#). The key headlines are that at the age of 16, students will choose between an academic option and a new technical option, and, be able to switch between the two routes. Under the technical option 15 routes will be available and within each route learners will choose between a two-year, college-based programme (including compulsory work experience), or an employment-based programme, such as an apprenticeship (including at least 20% college-based provision). Older learners will also be entitled to take these programmes. A transition year or traineeship will be available for those not ready to access a technical education route at 16.

The new, independent and employer-led body, the Institute for Apprenticeships will be expanded and be responsible for the new framework for technical education. It will have the remit to develop a coherent strategy and put employers in the lead of designing the standards across all technical education – college-based as well as apprenticeships. The plan sets out the timeline for reform between now and 2020, and further details from government on how the reforms will be implemented will be provided in the autumn.

Apprenticeships

DfE has published the long-awaited proposals for apprenticeship funding, and the new apprenticeship register, together with further information on how the levy will work, information on how much the levy will bring in, and an online calculator. A suite of documents are available:

Annex A looks at the proposed new funding bands for all current apprenticeships (frameworks and standards).

We have included the current apprenticeship standards rates for comparison. The current frameworks rates have not been included.

Reminder: DfE surveys on apprenticeship funding, and a new Register of Apprenticeship Training Providers

Just to highlight the two apprenticeship surveys again:

- DfE are inviting **views on the apprenticeship funding proposals in a survey which closes on 5 September**. Do respond to ensure your views are taken into consideration; your feedback will help DfE shape the final funding proposals which will be confirmed in October 2016.
- DfE are inviting **views on the proposals for a new register in a survey which also closes on 5 September**. Again, do respond to ensure your views are taken into consideration.

IPPR report: England's apprenticeships, assessing the new system

In their [report on the latest apprenticeship reforms](#) published this week IPPR supports the desire to create a strong apprenticeship system, but warns that the current apprenticeship policies are in danger of failing to achieve the government's aims. They identify four areas of particular concern: small and medium-sized employers may not offer enough apprenticeships, a market that delivers the cheapest possible apprenticeship for the largest group of people could develop in some sectors, there will be little additional training introduced as a result of the system, and the government's target to create 3 million apprenticeships will encourage as many starts as possible, which could see apprentices being placed on inappropriate levels; and make four recommendations for government: consider extending the levy to cover smaller employers, restrict apprenticeships to sectors in which apprenticeships can add real value, tighten up the regulation of the new apprenticeship standards, and encourage the growth of apprenticeships at level 3 and above.

FE data library: Updated apprenticeship data added

An updated file has been added to the [statistical data set from DfE and the SFA](#) which provides information on apprenticeships through a number of reports broken down by starts, achievements, sector, framework, geography, gender, age and others. 'Government funded apprenticeships starts and achievements 2007/08 to 2014/15' was added this week.
