Funding News this week reminds you where you can find all the funding regulations, and funding rates and formula documents for 16-19, 19+ and apprenticeship funding for 2016/17.

We also bring you a reminder of the suite of documents published by the DfE on 12 August about how the system will work after the levy is introduced in April 2017 and the new funding systems for all apprenticeships is introduced in May 2017. These cover: proposals for apprenticeship funding, a new register for apprenticeship providers, and further information on the levy. We also link to further information from the DfE on how much the levy will bring in, and an online calculator for employers. We have produced brief summaries of some of these and provide links here. The DfE is inviting feedback on two of the key documents: the proposals for apprenticeship funding, and the proposals for a new Register of Apprenticeship Training Providers. Both surveys close on Monday 5 September; do respond to ensure your views are heard.

Reminder: Changes to apprenticeship funding and the introduction of the levy

DfE has published the long-awaited proposals for apprenticeship funding arrangements once the levy is introduced. A suite of documents are available and all the documents referred to in this section can be found [here](#).

1) Proposals for apprenticeship funding

[Proposals for apprenticeship funding from May 2017](#) (23 pages) includes proposed funding bands for individual apprenticeship frameworks, and proposed funding bands for individual apprenticeship standards. Two Funding Focus documents are available summarising the proposals:

- [Funding Focus – Apprenticeship funding after April 2017](#) summarises the funding proposals under three headings: apprenticeship funding for levy and non-levy payers, apprenticeship funding for levy payers, and apprenticeship funding for non-levy payers. Annex A looks at the proposed new funding bands for all current apprenticeships (frameworks and standards).
- [Funding Focus – Proposed allocation of frameworks and standards to new funding bands from May 2017](#) provides a full list of the new proposed funding bands so you can easily see the new funding band your framework or standard has been allocated to. We have included the current apprenticeship standards rates for comparison. The current frameworks rates have not been included.

2) A new register for apprenticeship providers, and a guide for employers

Employers will need to know their organisation's annual UK payroll to use it.

Pearson qualification funding

Workskills qualifications from September 2016

Unfortunately the new [workskills](#) qualifications will **not be available for new starts for any age learners in September 2016 until further notice**. We have had to take this decision as the glh for the qualifications need to be reviewed. To ensure provision is still available for learners we have extended the exiting suite of workskills qualifications until 31 December 2016 and these will be eligible for both EFA 16-19 and SFA 19+ funding. The funding hub should be updated on 15 September to reflect this. The codes for the existing workskills qualifications are listed below. BTEC Firsts extended to 31 December 2019

We are [extending the last registration date for 88 BTEC Firsts](#) to 31 December 2019. This extension affects the BTEC Level 2 Firsts (2010), and the BTEC Level 1/2 Firsts (2012 and 2013).

- We expect EFA 16-19 funding to be extended on the funding hub in line with the extension.

- SFA 19+ funding is confirmed on a yearly basis but in 2017/18 the SFA will only approve technical and applied qualifications in the 2018 and 2019 16 to 19 Performance Tables as part of the 19-23 entitlement. We expect all the BTEC Firsts will continue to be eligible for local flexibility funding in 2017/18.

BTEC Firsts and Nationals funding in 2016/17

The Funding Focus – BTEC Firsts and Nationals - Adult funding in 2016/17 has been updated to include the funding information for Nationals newly approved for loan funding and will shortly be available on [Pearson Funding News](#). The tables capture the funding eligibility for the BTEC First and Nationals in 2016/17, and the document also provides guidance about learners starting QCF qualifications in 2016/17, or moving from smaller to larger qualifications in 2016/17 or 2017/18, and explains 19-23 eligibility for entitlement funding. As soon as the extension to the last registration date for the BTEC Firsts feeds through to the funding hub (see BTEC Firsts extended to 31 December 2019 above) this sheet will be updated with the new LDNS for these qualifications.
