

Funding Focus – Updated – BTEC Firsts and Nationals – Funding in 2016/17

7 December 2016

Funding Focus provides quick summaries of recent funding developments, or particular aspects of the funding system.

The tables in this document capture the funding eligibility for the BTEC First and Nationals in 2016/17. It has been updated since September 2016 to include the extension to [88 BTEC Firsts to 31 December 2019](#) as this information has now fed through to the funding [Hub](#).

As soon as we know more about SFA funding in 2017/18, this document will be updated.

Explaining the tables: further detail on the information included

EFA 16-19 funding: last date for new starts (LDNS)

- The EFA approves qualifications for funding until the end date of the qualification.
- The LDNS (last date for new starts (for funding)) for 16-19 learners is the last date by which an eligible learner must be enrolled on a qualification if they are to be eligible for funding.
- All the BTEC Firsts and Nationals listed are eligible for 16-19 funding in 2016/17.
- 88 of the BTEC Firsts have been extended until 31/12/2019. The EFA has confirmed (subject to any policy change) that these will remain funded until that date.
- (The SFA approves qualifications for adult (19+) funding for one year only, so the LDNS for all the qualifications eligible for SFA funding in 2016/17 (either local flexibility funding, or local flexibility funding and 19-23 entitlement funding) is 31/07/17.)
- EFA 16-19 and SFA 19+ funding for all qualifications can be checked on the funding [Hub](#).

SFA 19-23 entitlement funding 2016/17

- This column identifies the qualifications eligible for 19-23 entitlement funding in 2016/17.
- The SFA has approved qualifications for the 2016/17 19-23 entitlement using the criteria below (Core/non-core, and 16-19 performance tables).

SFA 19-23 entitlement funding: core/non-core, and 16-19 performance tables

- We have included this column as it explains why qualifications are, or aren't eligible for SFA 19-23 entitlement funding in 2016/17.
- Using the 16-19 performance tables, the SFA identified core and non-core qualifications for 2016/17 in the 19-23 entitlement. This approach is in place to support the SFA's transition towards a single 16 to 23 entitlement offer.
- **Core qualifications** are approved automatically and are qualifications in 2018 16-19 performance tables approved as Level 2 Technical Certificates (TC), or Level 3 Tech Levels (TL) or Applied General qualifications (AG). The SFA has also included some level 3 qualifications approved in 2017 16-19 performance tables.
- **Non-core qualifications** are those not approved in 16-19 performance tables, but which will be available for the 19-23 entitlement for 2016/17. They will not be eligible for 19-23 entitlement funding in 2017/18.
- **In 2017/18 only qualifications in 2018 and 2019 16-19 performance tables will remain eligible for 19-23 entitlement funding. Qualifications that are currently non-core, or core but only in 2017 16-19 performance tables, will not be eligible.**

SFA 19+ loan funding 2016/17 (BTEC Nationals only)

- Qualifications at level 3 can also be eligible for 19+ advanced learner loan funding and this information is included in the table.

ALSO NOTE

- Qualifications at level 2 (and below) can also be made eligible for 19+ local flexibility funding.
- All the BTEC Firsts are eligible for local flexibility funding.
- There is no list of qualifications eligible for local flexibility funding but these can all be found on the funding Hub. EFA 16-19 and SFA 19+ funding for all qualifications can be checked on the funding [Hub](#).

Further information: 19-23 entitlement funding

19-23 year-old s have an entitlement to full funding for an entitlement qualification at level 2 if they don't already hold a full level 2, and for an entitlement qualification at level 3 if they don't already hold a full level 3.

Full Level 2 is the level of attainment demonstrated by:

- A GCSE in 5 subjects, each at grade C or above, or grade 4 or above, or
- Technical Certificates on the 2018 16 to 19 performance tables, or
- Other technical and professional qualifications listed as level 2 legal entitlement qualifications which must be at least 150 glh

If a learner aged 19- to 23-years-old has achieved a level 2 qualification that was at the time they started, or still is, classed as a full level 2, then any subsequent level 2 qualifications will be co-funded.

Full Level 3 is the level of attainment demonstrated by:

- An A level in two subjects, or an AS level in four subjects, or
- A QAA Access to HE Diploma at Level 3, or
- A Tech level; or Applied general on the 2018 16-19 performance tables, or
- A number of Tech levels and Applied generals from the 2017 16-19 performance tables, or
- Other technical and professional qualifications listed as level 3 legal entitlement qualifications which must be at least 300 glh

If a learner aged 19- to 23-years-old has achieved a level 3 qualification that was at the time they started, or still is, classed as a full level 3, then any subsequent level 3 would either need to be loan-funded, or paid for by the student.

Further information: learners starting QCF BTEC Nationals in 2016/17 and 2017/18, or moving from smaller to larger QCF BTEC Nationals in 2016/17 and 2017/18

- All of the BTEC Nationals are eligible for 16-19 funding in 2016/17.
- The QCF BTEC Nationals have a LDNS of 31/12/17 so these qualifications will be available for 16-19 learners until that end date.
- The SFA has approved 'core' qualifications for 19-23 entitlement funding in 2016/17. These are qualifications approved in 2018 16-19 performance tables as Level 3 Tech Levels (TL) or Applied General qualifications (AG). The SFA has also included some level 3 qualifications approved in 2017 16-19 performance tables, and some non-core qualifications (see page 2 for more information).
- The SFA approves qualifications for 19+ funding for one year only so the LDNS for qualifications eligible for SFA funding in 2016/17 is 31/07/17.
- EFA 16-19 funded learners, and SFA 19-23 entitlement funded learners, may start on two-year QCF BTEC Nationals. EFA 16-19 funded learners may also, if they are not sure about talking on a two-year programme at the outset, start on smaller QCF BTEC Nationals in one year and then move to the larger qualification in the next. (See the section 'Further information: 19-23 entitlement funding' for why this is unlikely to be the case for 19-23 year-olds.)
- For funding purposes learners need to be enrolled, or move from a smaller to a larger qualification, before the LDNS (last date for new starts) for the qualification, for the particular age group.
- The LDNS is different for EFA funded 16-19 year-olds, and SFA funded 19-23 year-olds.
- EFA funded 16-19 year-olds who turn 19 during their study programme are funded under EFA rules and can be enrolled, or moved from a smaller to a larger qualification, before the LDNS for 16-19 learners. The EFA also fund learners aged 19 to 24 on the 31 August 2016 that have an Education Health and Care Plan (EHCP). These learners are also funded under EFA rules.
- The table below gives some examples of what this means for different age learners for QCF BTEC Nationals where the LDNS for 16-19 year-olds is 31/12/2017, and the LDNS for 19-23 year-olds is 31/07/16 or 31/07/17.

BTEC Firsts

- All of the BTEC Firsts are eligible for 16-19 funding in 2016/17.
- 88 of the BTEC Firsts have been extended until 31/12/19 so these qualifications will continue to be eligible for 16-19 funding. The BTEC Firsts that have not been extended will not be available in after 2016/17 as they have a LDNS of 31/08/17.
- The SFA has approved 'core' qualifications for 19-23 entitlement funding in 2016/17. These are qualifications approved in 2018 16-19 performance tables as Level 2 Technical Certificates (TC) (see page 2 for more information).
- All the BTEC Firsts are eligible for SFA 19+ local flexibility funding in 2016/17.
- The SFA approves qualifications for 19+ funding for one year only so the LDNS for qualifications eligible for SFA funding in 2016/17 (either 19+ local flexibility funding, or 19+ local flexibility funding and 19-23 entitlement funding) is 31/07/17.

These are qualifications approved in 2018 16-19 performance tables as Level 3 Tech Levels (TL) or Applied General qualifications (AG). The SFA has also included some level 3 qualifications approved in 2017 16-19 performance tables, and some non-core qualifications (see page 2 for more information).
- Many BTEC Nationals, including many not approved for 19-23 entitlement funding, are eligible for SFA loan funding in 2016/17.
