1 Scope of this section

1.1 Vocational qualifications

This part of the manual gives instructions and information on the administrative procedures for learners on programmes leading to vocational qualifications. These include all Pearson's Vocational Qualifications from Foundation level to Level 8.

The following areas are covered:

- registration
- reporting achievement
- claiming certification
- quality assurance.

It is important that this information is made available to the examinations officer/administrator, all coordinators and members of staff responsible for the preparation of documents for enrolment, registration and reporting achievement of vocational qualifications.

Please note that there are differences from standard BTEC QA and Administration processes which apply to Tech Awards from 2022. For more information, please visit <u>Quality Assurance BTEC Tech</u> Awards, L2 and L3.

Licence Agreement: BTEC Qualifications offered through Higher Education Institutes (HEIs) HEIs operating under the Licence Agreement are required to follow the administrative procedures detailed in the Licensed HN Centre Guide (<u>https://qualifications.pearson.com/en/qualifications/</u><u>btec-higher-nationals/about/pearson-licence-agreement.html</u>). The procedures set out in this section do not apply.

HEIs offering qualifications under the Pearson Licence Agreement are responsible for their own assessments, quality assurance, awarding and certifications. However, they are still required to record learner registrations and outcomes on our Edexcel Online platform (EOL) for all students taking any programmes approved under the Licence Agreement both on campus and at partner sites. Learners must only be registered under the HEI centre number and not the FE College centre number despite the FE College being a collaborative partner under the Licence Agreement.

For programmes not approved under the licence agreement, centres must follow the procedures set out in this manual.

Language of Assessment

The language of assessment is English unless agreed with Pearson. Centres are required to notify Quality Standard via the <u>support portal</u> where a programme is delivered solely in the medium of Welsh or Irish. For further guidance, please refer to the '<u>Use of languages in qualifications policy</u>'.

1.2 Collaborative arrangements and consortia

Where a centre works with other organisations or institutions to deliver programmes this is termed a collaborative arrangement. The lead centre has responsibility for the programme, and is the only centre that can make registrations and receive communications about the programme. All collaborative arrangements must be approved by Pearson prior to the commencement of programmes. The form alongside the policy can be found on our <u>Policies for centres</u>, <u>learners and employers</u> website page.

Where two or more centres work together to deliver a programme, which is jointly approved to both or all of them, this is termed a consortium. Each centre within a consortium registers its own learners using the single programme number assigned to all the member centres. However, quality assurance is carried out across the consortium as a whole, and centres will be reported on jointly with regard to programme quality and certification sign off. It is important that this information is made available to the examinations officer/administrator, all coordinators and members of staff responsible for the preparation of documents for enrolment, registration and reporting achievement of vocational qualifications.

2 Registration

2.1 Responsibility for registration

When a centre has enrolled learners onto an approved programme, or individual units, learners must then be formally registered with Pearson so that quality assurance can be implemented, achievement can be reported and awards issued. Responsibility for the registration of learners and for the payment of fees lies with the approved centre.

Centres operating under a collaborative arrangement are not able to register learners directly, and the responsibility lies with the approved centre to register learners and identify the collaborative centre attended by each learner. (Please refer to the Collaborative and Consortium Arrangements for the Delivery of Vocational Qualifications centre guidance available here).

Where two or more centres are operating as a consortium each approved centre within the consortium is responsible for registering their learners with Pearson. (Please refer to the Collaborative and Consortia Arrangements Application Form <u>here</u>).

Centres **must** ensure that learners are informed of their registration number when this is requested. It is not permissible to withhold a learner's registration number.

Note: Pearson reserves the right to refuse to accept new registrations from a centre if the centre has a debt outstanding to Pearson at the due date of submission of new registrations.

2.2 Registration deadlines

Enrolment is defined as:

- for knowledge-based programmes, the day on which delivery of the learner's programme/ unit commences
- for competence-based programmes, the day on which assessment of the learner's programme/ unit commences.

Programmes that follow the academic year

For programmes that follow the academic year, i.e. enrolment in September/October and completion in June/July, the registration deadlines are detailed below. Registrations received after the relevant deadline will be subject to late registration fees (please see Fees Information found <u>here</u>). Please also refer to the Late registration and certificate policy <u>here</u>. Centres must register learners prior to making entries for external assessments (please see the Entry and registration deadlines for 2024–25).

BTEC Programmes

The following deadlines for registration apply:

1 November 2024

15 November 2024

Level 4 HNCs and Level 5 HNDs

Level 3 and Level 4 Foundation Diplomas in Art and Design

Higher Education Licence Agreement registrations

Programmes that do not follow the academic year

This refers to all programmes that:

- enrol learners at any time other than September/October (including roll-on roll-off and onscreen tested programmes), or
- are of less than one academic year's duration, or
- are competence-based assessment programmes, e.g. NVQs/SVQs.

For Level 4 HNCs, Level 5 HNDs and the Level 5 Diploma in Education and Training, learners must be registered **within one month** of enrolment at the centre.

For other programmes, learners must be registered **within six weeks** of enrolment at the centre.

BTEC registrations received after the appropriate deadline will be subject to a late registration fee (please see Fees Information).

Any delay in registration may affect our capacity to provide centres with the assessment and verification opportunities that they require and, therefore, certification may be delayed.

Centres should note that this could cause problems for learners going through UCAS in order to enter higher education.

NVQ/competence qualifications

Registrations for the full Apprenticeship Scheme are due within six weeks of commencing the first component of the scheme. For Apprenticeship Schemes this may be when:

- · learners start the knowledge-based component
- assessment of the competence-based component starts.

Please refer to our guidance on how to make EDI/A2C registrations via Edexcel Online or EDI/A2C.

2.3 Periods of registrations

Registrations must be made before the end date given for qualification approval. Registrations are valid for a period of up to five years or until the issue of certificates, whichever is the earlier. A learner may only be certificated during this time. For qualifications accredited by the regulator, the final date is specified as shown on our website.

Where a registration exceeds the five-year expiry limit, the learner must be re-registered on a currently approved programme.

2.4 Registration: topping up

For regulated qualifications, learners may achieve at one qualification size and 'top up' to a larger size (e.g. Pearson BTEC Level 2 Certificate to Pearson BTEC Level 2 Extended Certificate) provided that both qualifications are based on the same specification, i.e. have the same unit identification codes.

To see your certification end dates please see your approved programmes on Edexcel Online, more information can be found <u>here</u>. Please do not make top ups unless learners will be able to complete programmes before the certification deadline.

Top ups are available for the following current qualifications:

- Foundation Learning Awards, Certificates and Diplomas
- First and National Awards, Certificates, Extended Certificates and Diplomas
- Level 4 HNC and Level 5 HND
- Level 3 and Level 4 Foundation Diplomas in Art and Design Specialist and Professional Awards, Certificates and Diplomas
- WorkSkills Awards, Certificates and Diplomas
- NVQ/SVQ Awards, Certificates and Diplomas Levels 1–8.

2.5 Registration: estimated completion dates

At the time of registration centres are asked to give an estimated completion date. These dates are used in relation to the allocation of Standards Verifiers and External Examiners and to support centres with the on-time issuing of qualification results. Centres must keep their learner registration up to date on our systems.

Failure to maintain learner registration data may results in maladministration actions.

2.6 Registration: programme numbers

Centres should check that the programme numbers used are those that match the programmes being delivered, particularly if registrations are submitted electronically.

Note: Whilst learners who are registered incorrectly may transfer to the correct programmes, this could delay assessment, quality assurance and certification. Centres are advised that it could also affect funding for the programme. Help with how to check your Centres Approvals can be found <u>here</u>.

2.7 Registration Amendments

Centres can amend learner registrations on Edexcel Online. A step by step guide can be found <u>here</u>.

2.8 Unique Learner Number (ULN)

The ULN is a learner identifier that is allocated by the government agency Learner Records Service (LRS) and is used in the recording of learner results across awarding bodies.

Pearson is able to accept the ULN in EDI/A2C entry, amendment and registration files and on any entries/registrations made through Edexcel Online.

It is not necessary for you to provide the ULN with entries or registrations; however, if a ULN is not provided then a learner's achievement may not be recorded with the LRS.

The ULN is a 10-digit number and it is important that you validate the ULN against the LRS before submitting the learner's entry/registration to Pearson. Please ensure that the personal details (name, gender and date of birth) being provided with the learner's entry or registration match exactly the details on the LRS. Pearson will check the ULN against the LRS and if there is a mismatch the ULN will not be accepted and a guery will be raised with you.

For further information about the ULN, and to find out how to obtain ULNs for your learners, please refer to the <u>LRS website</u>.

2.9 Deletion of registrations

Learner registrations will not normally be deleted or fees refunded once registrations have been accepted by Pearson. A new learner cannot replace an individual who has been registered and subsequently left the programme. However, we are aware that there may be learners who drop out from programmes early on and we will accept requests for the deletion of learners under the following circumstances. For guidance on how to delete your learners please click <u>here</u>.

Programmes that follow the academic year

We will accept a request for the deletion of a learner registered between 1 September 2024 and 31 December 2024. Centres can delete learners via the student record on Edexcel Online, or via an EDI/ A2C amendment file, at any point before 31 December 2024, provided the learner has not completed any units and no test bookings have been made.

Programmes that do not follow the academic year

Provided no units have been completed and no test bookings made we will accept a request for deletion, if we are notified via the <u>support portal</u> within two months of the date that we received the learner registration. For example, if a learner is registered on 1 March, we will accept a request for deletion up until 1 May. Please give the learner name and registration number in the email.

Deletions for Higher Nationals

From 1 January 2023, deletions for all Higher Nationals, regardless of whether your programme follows an academic year, must be made within 49 days of the student starting the programme of study (not from the date of registration). From 1 January 2023 any deletions made 50 days or more after the student's start date will not be eligible for a full refund.

It is important that the 'enrolment date' for your students is updated in Edexcel Online to reflect their actual start date if that is different to the pre-populated enrolment date of 01 September. The 49 days will run from the 'enrolment date' entered in Edexcel Online. More information on how to make deletions can be found <u>here</u>.

2.10 Withdrawal of learners

Centres should advise us of all learners who have withdrawn from programmes. Withdrawal can be made through Edexcel Online, or via an EDI/A2C amendment file, and can take place throughout the year. Withdrawal does not result in a credit back of any fees. Withdrawn learners may be reinstated via Edexcel Online at no extra charge. Click <u>here</u> for guidance on how to complete this process.

3 BTEC qualifications including external assessments

Many BTEC qualifications now include some elements of external assessment (an assessment that is set and marked (or moderated) by Pearson). Other assessments within BTEC qualifications are set and assessed by staff in the centre, and the outcomes are then quality assured and reported to Pearson.

For information on our External Assessments please see our <u>Exams Officers</u> webpages which contain information on key dates, timetables and unit information for all BTEC External Assessments.

For external assessments that are taken via onscreen tests, centres are required to install appropriate supporting software. For further details please refer to the onscreen testing guide on our website.

4 Reporting learner achievement

4.1 Responsibility

Centres are responsible for reporting on the achievement in internally assessed units for each learner, in respect of the assessment requirements for the programme for which they are registered.

The centre is also responsible for reporting success to Pearson for interim or final certification. Where programmes also include external assessment, the centre must ensure that appropriate assessments have been completed and that Pearson has data related to achievement – please refer to qualification specifications for further guidance.

Any amendments to reported grades are monitored and evidence of why grade changes for internally assessed units have been made may be requested at any time.

4.2 Unit grades

It is important that you report unit grades accurately according to the available assessment records for the programme and in accordance with the grading rules in the specification documents.

BTEC First, National and Higher National qualification units are always subject to grading except where otherwise indicated in the qualification specification documents. Achievement should be reported using the grades below:

U – Unclassified

P1 – Level 1 Pass (Tech award 2022) (NQF BTEC Firsts only and Legacy Tech Awards)

- M1 Level 1 Merit (Legacy Tech Awards only)
- P Pass
- M Merit
- D Distinction
- N (Nationals only)

Please refer to the specifications for each programme for full details. Centres must ensure they report grades correctly according to the status of the unit.

4.3 Overall qualification grades of achievement

The overall grade is calculated automatically from the unit grades reported (except Level 3 and Level 4 Foundation Diplomas in Art and Design where you will need to report the overall grade through Edexcel Online or EDI/A2C). For all other qualifications the centre does not need to supply further information.

Full details on the overall grades available and how they are determined are given in the specification document for each programme.

4.4 National Vocational Qualifications/Scottish Vocational Qualifications

In line with Ofqual regulations, the 10-week rule continues to be applicable to all NVQs accredited on the National Qualifications Framework (NQF). More information about the 10-week rule can be found <u>here</u>.

However, the 10-week rule has been removed for NVQ and NVQ Successor Qualifications accredited under the Qualification and Credit Framework (QCF). This means that there does not have to be a 10-week period between registration and applying for certification.

The 10-week rule does apply to all Scottish Vocational Qualifications accredited by SQA Accreditation.

All claims should be validated by an occupationally competent and qualified internal verifier. Centres must ensure that all claims for certification are authentic and valid and can be supported by auditable records.

4.5 Confirmation of learner achievement

It is essential that all centres issue annual reports of success to learners.

Centres reporting grades by EDI/A2C should issue their own centre report for learners, and centres using Edexcel Online should issue learners with the Edexcel Online report. It is most important that centres accept the responsibility to provide learners with evidence of their portfolio achievement in order that they have early official evidence of their success.

4.6 Reporting success to UCAS

In March/April each year we undertake a matching exercise with UCAS to identify those BTEC Level 3–5 learners who have applied to UCAS for entry to higher education courses.

These are learners who are applying for higher education places and are following BTEC Nationals, Higher Nationals, Level 3 and Level 4 Foundation Diplomas in Art and Design as well as any Level 3 Specialist courses that attract points on the UCAS tariff. During July/August we will provide UCAS with confirmation of these matched learners' achievements so that HEIs have the latest information on each applicant.

Where a match cannot be found, because of incorrect spellings or incorrect centre details, we will still be able to inform UCAS of these learners' achievements if you notify us of each learner's UCAS Personal ID number and UCAS Scheme Code by logging a ticket on the <u>Support Portal</u>.

It is important that results for these learners are reported to us by 5 July.

If you are reporting results to Pearson by EDIFACT EDI/A2C, we ask that you send a file earlier in July for your UCAS learners only, rather than include these learners in a larger file later in July.

Note: Centres should ensure that staff are available to respond to university queries during peak summer periods, and that results are sent to Pearson as soon as possible. This will enable issues to be resolved more easily.

Where learners achieve a qualification and top up to a larger qualification, e.g. Level 3 Certificate to Level 3 Diploma, it is essential that you top up the learner as soon as the smaller qualification has been achieved. This is so that we can match the new qualification with UCAS as early as possible and send the grade on completion.

4.7 Submission of results to Pearson

Interim reporting

Internally assessed unit results must be returned or results reported via EDI/A2C or Edexcel Online for every learner registered who has achieved unit success, and also where they have withdrawn from the programme. If they have already been deleted you do not need to include them in the report. Success on units should only be reported where all requirements have been met.

Where a BTEC programme contains both internally and externally assessed units, you should report internally assessment units as soon as possible, and no later than 5th July where results are required in August. Where a full award claims has been made, but an external assessment results are pending, we will issue the overall qualification result as soon as the externally assessed unit result is available.

Note: In all cases of interim reporting a Notification of Performance will be produced only if the option is selected by the centre.

Dates for grade reporting

In order to ensure that certification is received as soon as possible please refer to part 5.2 in this section for the required dates.

Please note: Results for qualifications where internally assessed grades are reported after 5 July may be issued after the published results date.

Note: Results should be submitted immediately at the end of each summer term, as the results submitted to Pearson are used, in some instances, to create the performance and league tables. If you have not reported early enough to enable us to process the results by the end of July, you may find your outcomes are incorrect in these tables. For work based learning, when summative internal quality assurance has occurred, the learner must be claimed on Edexcel Online without delay..

4.8 Methods of reporting

There are two electronic methods of reporting success:

- EDIFACT EDI/A2C transmission
- Edexcel Online.

Note: JCQ format EDI does not currently support the reporting of unit outcomes and award claims from centres to us. Centres using this format should use Edexcel Online to report success to us. (For example, SIMS uses JCQ format EDI.)

EDI/A2C transmission

Learners' unit results, certificate claims and withdrawals may be transmitted electronically by EDI/A2C (see EDI/A2C results reporting: EDIFACT EDI format on the EDI/A2C section of our website).

Results Entry 7B files

In order to receive learners' overall results via EDI, please ensure you have submitted a Results Entry 7B file by 31 May.

How to get a Results Entry 7B file

Log on to Edexcel Online, go to the *BTEC* section, then select *EDI Basedata*. Change the *Basedata Subtype* drop-down to *Results Entry 7B*, make sure the approval year is 2024–5 and select *All Approved Programmes*. Hit *Submit* and JCQ basedata will be sent to your Edexcel Online mailbox within a few hours. You will then be able to import it into your MIS and create your own Results Entry 7B results request file for the learners you need results for.

Changes to learner information

To ensure that your results in August are correct, learner details in the Results Entry 7B file must exactly match the current learner registration details.

If a learner has been transferred between programmes (for example from a Diploma to a Certificate) after your original 7B file has been submitted, please send us a new file with the updated details.

Edexcel Online

You can report results, claim certification and notify withdrawals through Edexcel Online (see qualifications.pearson.com/eol for how to gain access to it).

5 Certification

5.1 Certification deadlines

Data should be submitted for all learners via EDI/A2C or through Edexcel Online on these occasions:

- at the end of each year/stage of the programme: by 5 July for programmes following a normal academic year, or as soon as possible thereafter, even where learners are retaking assessments or tests (especially important for UCAS applicants)
- immediately after completion for non-academic year programmes
- on transfer of the learner to another programme/centre
- for all learners who have withdrawn from the programme, even where no success has been achieved (especially important for UCAS applicants).

Certificates will be delivered to centres within 14 working days of the print date.

Dates for the issue of certificates for BTEC NQF programmes containing an externally assessed exam, project or performance are in the Key Dates section of this manual.

In order to issue certificates in August, results should be reported by 5 July for every learner completing at the end of an academic year. Results must be reported for every learner who has achieved unit success and also where the learner has withdrawn from the programme. No action is required where a learner has not completed any units in year one of a two-year programme.

It is particularly important that, for learners who have made applications to HEIs through UCAS, results are reported by 5 July, even where the learner is retaking assessments and/or tests, so that HEIs have information on each applicant. A member of centre staff should be available during July/August in order to process any queries raised.

For guidance on how and when to report learner achievement please refer to the guidance.

Note: Results should only be reported if the centre has clearance to certificate through reports from Standards Verifiers or External Examiners.

6 Recognition of prior learning

Centres may make claims for some units or a whole qualification based on recognition of prior learning and/or experience. Please refer to the policy on Recognition of Prior Learning, found <u>here</u>.

After accepting a learner for assessment of prior learning, registration should be made in the usual way and RPL achievement may then be reported and graded where appropriate, using normal methods.

7 Reasonable adjustments, appeals and assessment records

7.1 Reasonable adjustments

Centres can put in place reasonable adjustment arrangements for learners with particular requirements if they have, for example:

- a permanent or long-term disability or learning difficulty
- a temporary disability, illness or indisposition.

These arrangements are intended to allow learners to demonstrate their achievement. However, any reasonable adjustment arrangements must not:

- advantage or disadvantage the learner
- alter the assessment demands of the qualification.

Centres should follow the policies and guidance.

Pearson reserves the right to request further clarification or information in relation to any proposed arrangements.

7.2 Appeals

As part of the approvals/centre recognition process, centres are required to provide evidence that they have a published internal appeals procedure which can be accessed by learners.

From time to time learners contact Pearson directly about issues relating to the delivery and assessment of the programme they are following. On receipt of any such communication we would, in the first instance, refer the learner back to the centre's own internal appeals procedure. Learners are advised that they must fully exhaust this system before Pearson can become involved.

If a learner does access the centre's internal system and does not feel that the outcome is satisfactory, they can contact Pearson again.

Learners should provide the following information when making an appeal to Pearson:

- an outline of the nature of the issue and details of communication with the centre
- evidence that they have fully completed the centre's internal appeals process
- clear details of why they feel the outcome to be unsatisfactory.

At this stage we would take the appropriate steps to investigate the complaint. The outcomes of any such reviews are confidential between Pearson and the centre. Pearson may charge for carrying out these reviews. Please refer to the document <u>Enquiries and Appeals about Pearson Vocational</u> <u>Qualifications Policy</u>.

Standards Verifiers are not permitted to arbitrate in appeals.

7.3 Centre assessment records

Centres are expected to make every effort to ensure the safety and security of learner work which they are holding for assessment purposes. Centres must ensure they have detailed and up-to-date assessment records for all learners, which are kept separately from actual learner work. Assessment and verification records left in learner portfolios are likely to be unavailable when learners leave programmes or complete certification. Centres need to retain assessment and internal verification records for three years following certification. Please refer to the centre guidance.

Lost or destroyed learner work

If learner work is lost or destroyed, centres will need to provide those assessment records that will verify what has been achieved in order to ensure that certification can proceed.

Centres must notify <u>uk.special.requirements@pearson.com</u> immediately if learner work is lost or destroyed, ensuring they provide the following information:

- · circumstances in which the work was lost or destroyed
- programme title and number
- details of the learner(s) affected
- details of which unit(s) are affected
- centre, programme and assessment records
- any evidence of internal verification
- any supplementary information, such as witness testimonies.

Each case will be considered individually and certificates may be granted if:

- sufficient centre records and supplementary evidence are available
- all other assessment on the programme has been subject to ongoing external quality assurance, which identifies that national standards have been met.

7.4 Work retention

For information on work retention please see **<u>BTEC: Retention Of Learner Work/Evidence</u>**.

8 Completion of quality assurance processes required for certification

8.1 Summary

BTEC programmes are operated on the basis that appropriate quality checks are completed prior to certification. Certification claims should only be made when centres have authority to do so. Claims made without authority may be blocked from processing or may lead to subsequent action by Pearson. Pearson reserves the right to suspend certification by a centre on a programme/unit if there are any concerns over standards, quality assurance or centre management.

Centres must allocate a Quality Nominee within Edexcel Online who will act as a point of contact for centre quality and be responsible to oversee completion of quality assurance activities.

8.2 BTEC qualifications Entry Level and Level 3

Qualifications that fall under the BTEC quality assurance model will follow a three-stage annual process based on an academic year:

Stage 1: (1 Sept – 14 Oct)

Annual Quality Declaration - submitted by the Quality Nominee (QN) or Head of Centre (HoC)

Centre Standardisation – Completed for every L2 and L3 programme by each Lead Internal Verifier (LIV), designated in a centre to take overall responsibility for assessment and quality assurance of a programme.

Stage 2: (1 Sept – End Dec)

Holistic review – Where required, we will allocate a Reviewer to provide additional support in relation to centre level quality

Stage 3: (End Jan – 15 May, first sample window)

Standards Verification - an annual process that takes place each year to conduct sampling of learner work. This is to ensure that Assessors are making accurate assessment decisions in a fair and consistent manner and must be completed successfully for certification to be released.

Quality Assurance Checks – internal checks and balances to ensure that results are accurate and submitted in a timely way.

8.3 BTEC Level 1/Level 2 Tech Awards (from 2022)

This suite of qualifications undertakes a moderation process that is different to other BTEC quality assurance models.

The following key quality assurance activities must be completed each academic year:

Annual Quality Declaration – submitted by the Quality Nominee or Head of Centre (1 Sept – 14 Oct)

Internal Standardisation – completed within the centre for each Pearson Set Assignment (PSA) series before assessment takes place, using exemplar standardisation materials

External Moderation – required for each PSA series to review the accuracy and consistency of assessment in your centre through the sampling of marked learner work.

8.4 BTEC qualifications Levels 4 to 7

External examination is how we check that centres are operating appropriate quality assurance and maintaining national standards for our BTEC Levels 4 to 7 (QCF and RQF) programmes and BTEC Level 3 and 4 Foundation Diplomas in Art and Design. Information and guidance, that provides more information on the processes and support to help you prepare, can be found in the BTEC Centre Guide to External Examination

All centres delivering BTEC Levels 4 to 7 (QCF and RQF) programmes and BTEC Level 3 and 4 Foundation Diplomas in Art and Design are subject to a visit from Pearson-appointed External Examiners (EEs). The outcome of external examination will be:

- to confirm that internal assessment is to national standards and allow certification, or
- to make recommendations to improve the quality of internal assessment before certification can be released.
- Centres must give full and serious consideration to the comments and recommendations contained in external examination reports. The actions taken as a result of reports, or the reasons for not following recommendations, should be formally recorded and circulated to those concerned.
- Centres must ensure that student representatives are given the opportunity to be fully involved in the external examination process, enabling them to understand all of the issues raised and the centre's response. At centre-level, the general issues and themes arising from the reports should be reviewed whilst maintaining the confidentiality of the students whose work has been sampled.
- Alternative providers delivering HNC, HND and/or BTEC Management qualifications Levels 4 to 7 are also subject to Academic Management Review, which is an annual centre quality visit for UK Alternative Providers.

8.4.1 NVQ/SVQ and BTEC Apprenticeship programmes

NVQ/SVQ and BTEC Apprenticeship programmes are subject to standards verification. A subject specialist Standards Verifier is allocated to visit a centre to undertake a review of programme management and sample assessed, internally verified evidence.

The following regulations specify the quality assurance and control requirements that apply to NQF NVQs, QCF NVQs, SVQs and competence-based qualifications:

- Ofqual/CCEA Regulation General Conditions of Recognition
- Qualifications Wales Standard Conditions of Recognition
- SQA Accreditation Regulatory Principles (2014).

All staff involved with the delivery of NVQs and SVQs should be familiar with their contents. Copies of the documents can be found on the regulators' websites (Ofqual/CCEA Regulation/Qualifications Wales and SQA Accreditation).

8.4.2 Pearson BTEC Higher Nationals

Pearson's quality assurance system for all Pearson BTEC Higher National programmes is benchmarked to Level 4 and Level 5 on the Quality Assurance Agency's (QAA) Framework for Higher Education Qualifications (FHEQ). This will ensure that centres have effective quality assurance processes to review programme delivery. It will also ensure that the outcomes of assessment are to national standards.

As it includes additional elements that are not required for other Pearson qualifications, we term this 'enhanced' quality assurance. More details of the Pearson BTEC Higher Nationals enhanced quality assurance can be found here.

The enhanced quality assurance process for providers offering Pearson BTEC Higher National programmes comprises five key components:

- 1. The approval process
- 2. Monitoring of internal provider systems
- 3. External examination
- 4. Annual Programme Monitoring Report (APMR)
- 5. Annual Student Survey.

External examination for Higher Nationals

External examination is used to check that centres delivering BTEC Higher Nationals are operating appropriate quality assurance and meeting both national standards and expectations within UK Higher Education. Information and guidance can be found in <u>BTEC Higher Nationals Guide to External Examination</u>.
