Educational Credential Evaluators, Inc.

(ECE www.ece.org) is a private, non-profit organization that prepares evaluation reports that identify the United States equivalents of educational qualifications earned in other countries. ECE is a charter member of the National Association of Credential Evaluation Services (NACES), an organization to establish and maintain professional standards for private credential evaluation services.

ECE recommends that for each GCE or International Advanced Level studied, a learner has completed 10 semester hours of undergraduate credit.

International Education Research Foundation

(IERF, www.ierf.org) is a not-for-profit, public-benefit agency and is the oldest credentials evaluation service in the world. It has conducted thousands of evaluations on educational credentials from the United Kingdom. Its evaluators have also presented on and contributed to publications on the educational system in the UK.

IERF recommends that for each GCE or International Advanced Level studied, a learner has completed approximately 6-8 semester hours of undergraduate credit.

World Education Services

(WES, www.wes.org) is a non-profit organization that provides research about international education and trends and offers expert credential evaluation services. Each year WES helps 170,000 internationally-educated students and immigrants pursue their goals in the US and Canada.
