Pearson has selected Rogo to become its primary supplier for delivering all our End-Point Assessment (EPA) knowledge tests.

How does it work:

Rogo uses an internet browser to deliver tests; this eliminates the necessity of downloading & installation of offline software to administer tests to apprentices.

Inclusive to Rogo is a remote invigilation service that allows you the apprentice to take your tests in the convenience of your own home or workplace without requiring an invigilator. Your training provider will schedule your EPA knowledge test via ACE360's booking tool selecting the appropriate delivery method - either a traditional invigilated online test, or a remote invigilated online test.

Apprentice Assessment Checklist

Below is a checklist required for onscreen EPA knowledge tests using Rogo. Your training provider will be in touch to discuss dates for when to undertake the EPA knowledge test, once confirmed they will make the booking through ACE360 which feeds into Rogo.

Before taking your onscreen EPA knowledge test, please go through the checklist below to ensure you are fully prepared.

Technical Requirements

Please see the table below which shows the system requirements that your laptop/desktop PC will need to be able to successfully take an onscreen EPA knowledge test using Rogo. It also shows any additional equipment that is required, if using remote invigilation for example.

How to check the installed Windows version:

- Click on the **Search** button, next to the Windows icon on your taskbar.
- In the search box, type **Control Panel** and press Enter.
- · Change the view options to Large or Small icons (based on your preference).
- Select the option for **System**; this will display the current version of Windows that is installed.

How to check the installed MacOS version:

- In the left-hand corner of your screen, there is an **Apple** icon, please click on it.
- A menu should expand, please click on **About this Mac**, this will display the current version of MacOS that is installed.

Important: If you usually stream films on your laptop and you find it needs to buffer or load throughout the film, then this could mean your internet speed is not strong enough to complete the onscreen EPA knowledge test.

Technical Support and Troubleshooting

Unable to access Rogo using the device verification link?

- Please ensure that the <u>technical prerequisites</u> have been met.
- Check that there are no active VPNs (virtual private networks) on your device.
- Try a different internet browser.
- Ensure that you disconnect all other devices connected to your network.
- Please check that <u>https://pearson-epa.ace360.org</u> has been whitelisted (trusted sites) in the internet settings.

If any of the above fails to resolve their issues, please **clear your internet cache** using the steps below.

Technical Support and Troubleshooting cont.

Cannot scan the QR code or there is a problem with the mobile feed

- Only scan the QR code with the stock pre-installed camera application or a QR code reader application.
- If the feed is a blank screen please click on the link on your mobile device to see if it connects to your camera.
- **Ensure** you copy and paste the link to one of the above mobile internet browsers.
- If the mobile feed still does not work, please proceed with the onscreen EPA knowledge test, and inform your training provider.

Screenshare is not working

- Please ensure that the **technical** prerequisites have been met.
- Check that there are no active VPNs (virtual private networks) on your device.
- Close all internet browsers and start again.
- If the **share** button is inactive, make sure that you have clicked on the image of the screen that you wish to share.
- You should only have one instance of Rogo running.
- Make sure that you are sharing the entire screen and not only the application window or specific Google Chrome or Microsoft Edge tab.

Webcam is not working

- Please ensure that the **technical** prerequisites have been met.
- Check that there are no active VPNs (virtual private networks) on their device.
- Ensure the internet browser is not blocking access to the camera.
- · Close all other applications that might be using the camera.
- · If you are unable to get the webcam working, please proceed with the onscreen EPA knowledge test and inform your training provider.
 - You will be required to send in a picture of yourself and a copy of your photographic ID to satisfy examination conditions.

Requesting additional time for an EPA knowledge test

Please use the **reasonable adjustments** feature in ACE360 to submit a request with the relevant supporting evidence for additional time based on learning needs. Once a member of the EPA Delivery team has approved the request, you can create a booking in ACE360 for the EPA knowledge test. The booking will include any approved reasonable adjustments and when the test session is created in Rogo, the approved additional time can be applied.

Using onscreen text readers

Yes, Rogo is compatible with onscreen text readers such as Read Aloud. As long as the web browser extension has been installed in either Google Chrome or Microsoft Edge, it will function during the onscreen EPA knowledge test. Before using any screen reader extension, please ensure you have submitted a **reasonable adjustments** request in ACE360 with the relevant supporting evidence.

Colour screen overlays

Yes, colour overlays can be used in Rogo for the onscreen EPA knowledge tests. These can be physical overlays that are applied to the computer screen or built-in colour filters in the computer settings to simulate the same effect. To use a built-in colour filter on the computer, please refer to these steps provided by Microsoft and Apple: <u>Windows 10</u> - <u>Windows 11</u> - <u>MacOS</u>

Hearing aids

Yes, hearing aids can be worn by apprentices throughout their onscreen EPA knowledge test. Where an apprentice will be using the remote invigilation service, please ensure you have submitted a **reasonable adjustments** request in ACE360 with the relevant supporting evidence.

After the reasonable adjust request has been approved, please make a note of this in the **Additional Notes** field of the booking request in ACE360. This will inform Pearson's team of remote invigilators when viewing the recording that it does not need candidate malpractice review for this reason.

Increasing the font size

The font size in Rogo can be easily adjusted to make the text size as big as required for each apprentice's needs. As Rogo is housed within an internet browser such as Google Chrome or Microsoft Edge, you can simply use the in-built browser zoom functions.

This can be done by holding down ctrl on the keyboard & using the mouse wheel to zoom in and out.

if you are using a laptop trackpad, please click on the ellipsis button in the top right-hand corner of the internet browser (three vertical dots or three horizontal dots). A menu will expand and there will be a **Zoom** indicator, you can increase or decrease the zoom level as desired. Rogo will automatically adjust the formatting of the text to ensure nothing goes beyond the screen barriers.

Receiving Emails and Updating your Login Details

If your training provider has scheduled an EPA knowledge test, but you've not received an email from Rogo, here's what to do...

Before contacting Pearson, please check your junk/spam email folders as the emails issued by Rogo may get flagged as junk/ spam by your email provider. If you still have not received either your Welcome to Rogo email or the EPA Knowledge Test Booking Confirmation email, please contact **epatestdelivery@pearson**. com with your name and email address where a member of the team can manually reissue the specific email to you.

Updating your details.

Once a date has been agreed between you (the apprentice) and the training provider for the EPA knowledge test, a booking can be made through ACE360. After the booking request has been submitted successfully, the EPA Test Delivery team will use the information and create your (apprentice) record & test session in Rogo.

- You will receive a welcome email from Rogo which will provide you with your login credentials.
- Included in the welcome email will be a direct website link to access <u>Rogo</u>.

Accessing the EPA Knowledge Test

Device Verification

You will receive the second email, **EPA Knowledge Test - Booking Confirmation** at the minimum, 48 hours prior to the scheduled date. In the email will be a device verification link, this will need to be clicked first to ensure that the device that you are taking the EPA knowledge test on meets the **technical requirements**; **this applies to both remote invigilation and traditional invigilation methods**.

Accessing the Onscreen EPA Knowledge Test

Once the device verification has been completed, you can login to Rogo to access the EPA knowledge test, this can be done by either returning to the **EPA Knowledge Test - Booking Confirmation** email or directly via the **login screen**. After entering Rogo, you will be presented with all EPA knowledge tests (including any practice EPA knowledge tests) that you have been registered against, this can be filtered by **Active** or **Expired** by using the appropriate radio button.

Accessing the EPA Knowledge Test

If your onscreen EPA knowledge test is being invigilated traditionally (in-person), please continue to <u>Traditional Invigilation</u>; if it is being taken online through the remote invigilation service, please click <u>here</u>.

Traditional Invigilation

Please note: Where there is an invigilator present, you will not be required to share the computer screen, camera, or microphone when taking the onscreen EPA knowledge test in the workplace, or the training provider's premises.

The only prerequisite is that the device verification has taken place beforehand (in the **EPA Knowledge Test - Booking Confirmation** email) to ensure the computer is compatible with Rogo.

Before starting, you will be presented with **Instructions**, **Information**, **Advice**, and a **Learner Agreement** - providing that you are happy to proceed, please click **Start** to **begin** the onscreen EPA knowledge test.

Remote Invigilation

Rogo will prompt you to share the computer screen followed by a request to allow access to the camera and microphone - **this is mandatory for remote invigilated onscreen tests**. There will be a disclaimer on the screen to inform you at this point during the setup that recording has begun.

Remote Invigilation

Rogo will prompt you to share the computer screen followed by a request to allow access to the camera and microphone - this is **mandatory for remote invigilated onscreen tests**. There will be a disclaimer on the screen to inform you at this point during the setup that recording has begun.

There will be an onscreen prompt to position yourself inside an onscreen wireframe to take a still photo - there will be an example provided to help guide you. The photo can be retaken on this screen only (if you are unhappy with the photo). This will be used to verify your true likeness against the form of identity supplied later in the setup.





You will now need to take a photo of your identity document, this can be a **driving licence, passport, workissued ID, or another form of government ID (with a photo)**; this will be used by Pearson's team of remote invigilators when reviewing the recordings to verify the identity of the person taking the onscreen EPA knowledge test.

- Turn on Airplane Mode on your phone
- Turn on Wifi
- Open your camera app or QR reader
- Scan the QR code above, and follow the link
- · Choose to share your front camera

At this stage of the setup, it will be time to sync a mobile device (a smartphone or tablet) with Rogo by scanning a generated QR code. There will be instructions provided onscreen on how to link the devices.

Remote Invigilation cont.

Now that the mobile device has been synced with Rogo, it can act as a secondary camera. The **environment setup** can now begin, this is where Rogo will prompt you to use the secondary camera to show the following areas:

- · Computer and keyboard
- · Desk and area behind the computer
- Ceiling and the space under the desk
- The four corners of the room
- Show your ears to ensure no earphones are present

Once the above checks have been completed, you will need to position the mobile device on either the right or left-hand side so that the secondary camera (on the mobile device) captures your side profile and computer screen.

Important: Please ensure that the mobile device is connected to a power source.

Rogo will ask you to sit directly in front of the webcam, and that your face is in the centre of the frame. Clicking on Done - Next Step will complete the setup and you can begin the onscreen EPA knowledge.

After clicking on **Continue**, the onscreen EPA knowledge test will begin to load. Before starting, you will be presented with **Instructions**, **Information**, **Advice**, and a **Learner Agreement** - providing you are happy to proceed, please click on **Start** to begin the onscreen EPA knowledge test.

Throughout, questions will be split into several manageable sections; if you are unsure at the time of answering any of the questions, the section can be flagged.
