The Technical Qualification in Finance is split into two parts (known as Components). The Core and the Occupational Specialism.

The financial services sector

The Occupational Specialist Component is where you'll really get stuck in and develop the specific financial skills related to your chosen occupation specialism in preparation for your career in industry. There are four Occupational Specialisms to choose from:

Retail and Commercial Banking Analyst

In this component you will:

- Operate ethically and professionally in all interactions with customers/clients.
- Explain products and services in retail and commercial banking to internal and external customers/clients.
- Apply principles of risk management when making recommendations to internal and external customers/clients.
- Analyse financial information and data and present reports to internal and external.

Investment Banking and Asset and Wealth Management Analyst

In this component you will:

- Operate ethically and professionally in all interactions with customers/clients and counterparties.
- Explain products and services in investment banking to internal and external customers/ clients and counterparties.
- Explain products and services in asset and wealth management to internal and external customers/clients.
- Apply principles of risk management in investment banking and asset and wealth management.
- Analyse financial information and data and present reports to internal and external customers/clients/counterparties.

Insurance Practitioner

In this component you will:

- Operate ethically and professionally in all interactions with customers/clients.
- ► Carry out with guidance the delivery of insurance services to customers/clients.
- Apply principles of risk management when making recommendations about insurance products and services to customers/clients.
- Research and analyse financial information and data and present reports to internal and external customers/client.

Financial Compliance/Risk Analyst

In this component you will:

- Operate ethically and professionally in all interactions with customers/clients.
- Communicate risk implications of products and services to internal and external customers/clients.
- ► Communicate regulatory implications of products and services to internal and external customers/clients.
- Investigate and analyse potential risk or regulatory issues and present finding.

How will I learn?

The T Level Technical Qualification in Finance is intended to be as practical as possible.

You will not only learn financial services skills in preparation for your career, but you'll also be undertaking lots of practical hands-on activities, project and tasks to give you the experience employers are looking for.

You will also enhance your broader skills in literacy and numeracy, which will be valuable in supporting progression in other areas. In addition, you will develop transferable technical and practical skills in communication (working with colleagues, customers and clients), research and project work,

providing you with an opportunity to demonstrate your reflective practice.

What careers could this lead to?

The qualification is intended to help you progress into highly skilled employment in the financial services sector, with a focus on either banking, asset and wealth management, insurance services, or compliance risk. or compliance and risk.

Job roles open to you once you complete your T Level could include:

- ▶ Compliance Officer
- Risk Officer
- Financial Adviser.
