## **When do nominations for the BTEC Awards close?**

Please submit your BTEC Award nomination(s) by 17.00 (GMT) on Friday 25 March 2022. Nominations should be submitted via the ► [Nomination Form](#) on the website. Any nominations received after this time unfortunately will not be accepted.

## **Who can submit a BTEC Award nomination?**

We can accept nominations from teachers/tutors, heads of department, principals and assistant/deputy principals. Unfortunately, we are unable to accept nominations from learners or parents. If a learner or parent would like to submit a BTEC Award nomination, they should seek assistance from a member of staff at their centre.

## **Are there any requirements on the school/college which nominates learners for the BTEC Awards?**

## **Would learners that completed their studies last July be eligible for the learner's award categories?**

Learner nominees must have received, or be due to receive, their final BTEC grades between 1 June 2021 – 30 June 2022. For details, please refer to the ► [Learner eligibility criteria](#).

## **If we submitted a nomination last year, can we submit a nomination for this year?**

Yes, you can. You can nominate as many BTEC learners and educators as you like, however we are only able to accept one nomination per nominee. Where multiple nominations are received for the same nominee, we will accept the first time-stamped nomination.

## **Can an institution win the award in two consecutive years?**

BTEC providers (institutions) are eligible to win across consecutive years. Please refer to the ► [Provider eligibility criteria](#) to check that your centre meets the award requirements. You will also find handy information in the ► [Nomination Guide](#) to help support your nomination.

## **Can I nominate a learner who has not yet completed their BTEC studies?**

Yes, as long as the learner you nominate has received, or is due to receive their final BTEC grades between 1 June 2021 – 30 June 2022. Please see the ► [Learner eligibility criteria](#) for a full list of requirements.
