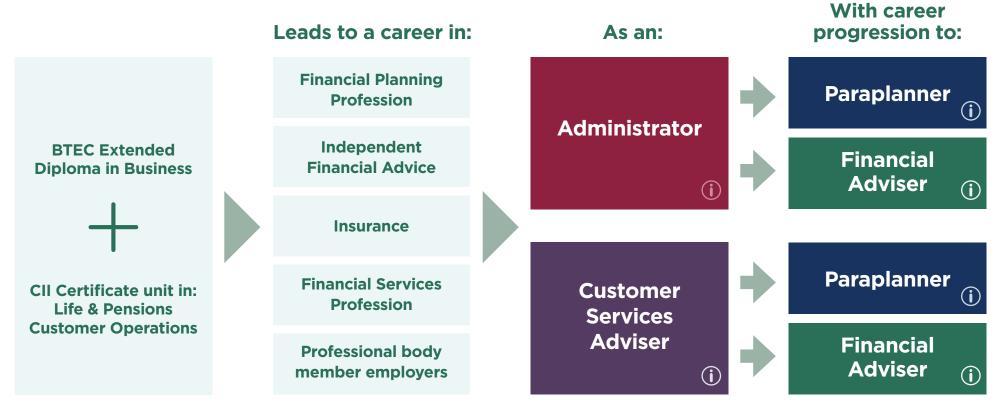






#### **Certificate in Financial Planing - Life & Pensions route**

#### Responsibilities

- Use a variety of software packages (including Microsoft Excel, Word, Access and Outlook, PowerPoint) to manage data and produce documents and presentations.
- Use content management systems (CMS) to maintain and update websites and internal databases.
- Keep diaries and arrange appointments.

- Book meeting rooms and conference facilities.
- Liaise with staff in other departments and with external contacts.
- Organize travel and accommodation for staff and other external contacts.
- Manipulate statistical data.
- Arrange in-house and external events.

#### Responsibilities

- Telephony answering calls, emails and web chat enquiries from businesses, private or company investors, customers or members of the public.
- Customer Service dealing with customer queries, customer payments, enquiries and complaints.
- Sales advising about products and services.
- Supporting customers to fix computer problems, updating customers' records on computer databases.
