## What does the qualification cover?

The qualification has been designed in consultation with employers, professional bodies and higher-education providers to ensure that the content is appropriate. Learners will be required to take mandatory units that are directly relevant to the progression routes they have identified. In addition, learners can take optional units that support the progression route identified in the qualification title.

Learners looking to follow a sport route could take units such as:

- Self-employment in Sport and Physical Activity
- Influence of Technology in Sport and Physical Activity
- Business in Sport.

### How are they assessed?

BTEC International qualifications are internally assessed to allow for practical assignments that combine knowledge and career-related skills. At least 25% of these assignments will be set by Pearson to provide additional external standardisation. Assignments are scenario-based and designed to be work relevant, for example by researching and presenting information and demonstrating the skills needed for employment.

### What are the progression routes?

BTECs are designed for progression into employment and will enable learners to either start their own business or progress to further education.
