

# Pearson Approved Centre for BTEC International Sport



## Additional Terms and Conditions

Pearson has developed its BTEC International Sport in partnership with Liverpool Football Club to provide an authentic teaching and learning experience.

As a Pearson approved centre ('centre') approved by Pearson and sanctioned by Liverpool Football Club ('LFC') to deliver BTEC International Sport qualifications, our centre agrees to abide by the following additional obligations as set out below, in respect of the following:

1.1	comply at all times with local legislation and any Pearson policies or requirements communicated to me from time to time by Pearson;
1.2	acknowledge the right for LFC or its agents or representatives to have access to reports and data gained by Pearson during inspections of our centre and at any time relating to the delivery of the Sports BTEC Qualifications to ensure compliance with our centre's obligations as a Pearson BTEC Approved Centre; this includes but is not limited to LFC checking our centre's use of LFC's licensed Trade Mark and other Intellectual Property used in the delivery of the BTEC qualifications;
1.3	take all necessary steps to ensure that any of our centre's employees that Pearson reasonably considers to be negatively affecting the delivery of the BTEC International Sport qualifications at our centre no longer be associated with or engaged by our centre;
1.4	ensure at our centre's own expense that any employees that may come into contact with our students have been fully background-checked and declared suitable to work in close proximity to children;
1.5	in accordance with clause 1.4 above provide evidence to Pearson, which can be viewed by LFC, of the background checks carried out on employees. Such declaration shall include but not be limited to any necessary local legal requirements such as the equivalent to the Disclosure and Barring Service (DBS) check in the UK;
1.6	not permit any photography, record, broadcast or film (by any means whatsoever) of any part of the BTEC qualifications which shows LFC's involvement in the course, without prior consent of LFC and ensure that: 1.6.1 notices are posted restricting photography at our centre and 1.6.2 wording restricting photography is contained in student registration terms and conditions;
1.7	comply with any applicable policies in relation to child protection, including but not limited to LFC's Child Protection Policy (such Policy may be amended by LFC from time to time);
1.8	accept that Pearson may remove our centre's approved status with immediate effect by written notice where, following a review by Pearson of our centre and our centre's delivery of the BTEC qualifications, Pearson determines that our centre is no longer compliant with the obligations set out in this term sheet;
1.9	warrant that our centre shall not in any way associate LFC, the BTEC qualifications or itself with any product that will or could shock or offend, or adversely affect the brand image or reputation of Pearson and LFC or any of their commercial partners/sponsors;
1.10	not associate in any way LFC or BTEC qualifications with any third-party organisations, products or services unless agreed in advance by Pearson and LFC;
1.11	not use any LFC intellectual property, references, assets, designations, images, titles or content in any format whatsoever, except the pre-approved assets specifically created and made available in the marketing toolkit by Pearson. Please refer to the toolkit for additional guidance on use of assets;
1.12	not promote our centre as being approved by LFC;
1.13	warrants and represents that our centre is not currently party to and during our Approved Centre status will not enter into any agreement with any other football team, football club, football federation or football training provider (other than LFC) for the delivery of similar qualifications unless LFC and Pearson consents otherwise (for the avoidance of doubt, such consent being on a case by case basis).
