Set Assignment 1 For use with either Assessment Unit A1/B4/C7/D10 or E13

ACTIVITY 1

The aim of this activity is for you to undertake production arts roles in 3 productions and to demonstrate how you have developed your skills and techniques in your chosen areas in your showcase.

- 1. You must show how you have approached each of the 3 roles. Each of the 3 productions should have a different theme or purpose so that you can show a diverse set of approaches to your work and define how you have developed and refined a wide variety of skills.
- 2. Your work in each of the 3 production arts roles should show a professional and diligent attitude accompanied by a creative and innovative approach to refine, develop and your skills at every opportunity.
- 3. You should regularly document and update your progress in developing the production arts skills and ensure that all the appropriate documentation for each rolebe it risk assessments, designs, meeting minutes etc has been completed. This might be demonstrations to camera or screen recordings with audio commentary, with appropriate annotated photos, worksheets, diagrams, designs, sketches, cue sheets, etc.
- 4. You should endeavour to provide an ongoing perceptive critical analysis of how your production skills have been refined, with reference to pertinent examples and insightful intentions.
- The evidence you will need to provide for this activity is a digital showreel- this can be a vlog, a website, a blog and/or an edited video
- The showreel should showcase the development of each of your 3 roles and include the appropriate documentation which should be clearly identified and presented in your chosen digital format.
- The hard copies of the documentation could also be made available if required, but this would be in addition to being within the digital format and not instead of.

Set Assignment 2 For use with either Assessment Unit A12/B5/C8/D11 or E14

ACTIVITY 2

The emphasis of this activity is on your individual contribution to the production arts role. The aim of this activity is to show how you personally as a production arts practitioner have responded to a directors brief for a specific production. You will showcase your journey from the first reading of the brief , through the creative and refinement process of all aspects which are required for your production role, then to the technical rehearsal process and finally to the production At all times you must show that you have the appropriate departmental specific paperwork documentation in place for your role

- 1. You will respond to the brief and show the use of a range of exploratory techniques in the development of production requirements, with reference to pertinent examples.
- 2. You will then apply your skills to in response to the purpose of the brief and demonstrate a proficient and fluent ability to apply appropriate skills and techniques that develop and enhance the purpose of the production/role.
- 3. You will show your journey through the complete rehearsal process from the read through right through to the technical and dress rehearsals and then the final production
- 4. Finally, you should review how the process has worked and provide a perceptive critical analysis of how production elements have been refined, with reference to pertinent examples and insightful intentions.
- The evidence you are required to produce for this activity is a digital showreel This
 could be a website, a vlog, a blog or an edited video, This showreel should include a
 Process log accounting for the response to the brief and the development of the
 project, which details both the creative and technical processes pertaining to the
 requirement and purpose of the production. It should include evidence for each of the
 numbered points
- To log your progress- this might be a video recording with audio commentary, video presentation or annotated pictures, with accompanying department-specific required paperwork/documentation
- The technical, dress and final performances may be a video recording of both the backstage and the audience view of the production, with accompanying department-specific required paperwork/documentation.
- The review and analysis can be ongoing via video logs, podcasts etc

Set Assignment 3 For use with either Assessment Unit A3/B6/C9/D12 or E15

ACTIVITY 3

The emphasis for this activity is on the role of the individual working successfully within a team

For this activity you are required to show that you have successfully taken part in a major production in a production arts role, working diligently as part of the wider production team.

- 1. Your task is to document the full and complete aspects of the role undertaken during the rehearsal process right through to the production as a vital part of the production team, documenting discussions, liaisons, compromises, and meetings. This should clearly show how you have responded to other team members ideas and working practices. It should also demonstrate accomplished technical proficiency, proactivity in being a team member and a detailed response to the workload. This should include collecting evidence and comments from other team members
- 2. You should document an approach to rehearsal with sustained and mature engagement and discipline, demonstrating a perceptive application of techniques and proficient collaborative working that contribute to the progression of the rehearsal.
- 3. You should express how individual actions and decisions led to production element developments, with clear reference to relevant, reasoned and detailed examples and developmental targets.
- The evidence required for this activity is a digital showreel of the process- this can be a vlog, a website, a blog and/or an edited video It should have materials demonstrating engagement within rehearsal sessions and the technical rehearsal.
- This might include videos or audio recordings of rehearsals, group discussions/production meeting minutes, written commentary, emails, feedback notes, rehearsals and show reports.
- A video recording of a final completed performance should be included giving a clear indication of how your role contributed to the team effort of the production.
