Instructions to Learners

You will be asked to carry out specific activities using the information provided. You will be given a specific time period to complete the assignment including time to gather your research.

Your notes should:

- be individually and independently prepared by you
- use short, bullet-point style information, and cannot contain long narrative pieces of text.

At a times you must work independently and must not share your work with other learners. You must complete an authentication sheet and submit this along with your work. This document contains the information you need to prepare for the Set Assignment.









Set Assignment

You must complete ALL activities within the task.

Activity 1

Examine organisations of the sport and active leisure industry and its provision in your country.

You will need to investigate:

- Different organisations and structures of sport and active leisure in the public and private sectors
- Scope and provision of the sport and active leisure industry
- Participation in sport and active leisure
- Barriers to participation

The sport and active leisure industry is constantly changing and growing with many different opportunities for employment. For a successful career it is vital to understand the behaviours, values, skills and techniques required to apply for one of these opportunities.

You are embarking on your career journey and are exploring opportunities that will be accessible to you after successfully completing your BTEC qualification.

You are required to research organisations and job roles in the **private sector** in the sport and active leisure industry

You will be required to undertake your own skills audit, analyse the most appropriate career choice, evidence a job application process, and reflect on your own personal development plan.

You are required to independently produce a report on a private sector organisation in the sports and active leisure industry in your own country.

Your report should include information on:

- the organisation and structure of the sport and active leisure industry.
- the scope and provision of sport and active leisure
- the reasons why people take part in sport and active leisure and barriers to participation in the sport and active leisure industry

- Health and Safety
- safeguarding provision.

Activity 3

Investigate careers in the sport and active leisure industry

You will need to investigate:

- Careers and job roles in the sport and active leisure industry in the public and private sectors
- Health and safety at work and employment law
- Safeguarding and protection of children and vulnerable adults in sport and active leisure

You will prepare summary notes to support you. Your notes should:

- contain your portfolio of job application information
- record of your job interview
- skills audit
- reflective personal development plan.

You have completed research and explored various career options within the sport and active leisure industry.

For the next stage of your career development and to complete your portfolio of evidence you now need to:

- produce a skills audit for the career identified in either Activities 2 or 3
- produce a portfolio of evidence to support your choice.
- complete an application process (producing a CV and a covering letter)
- attend an interview
- review your own strengths and weaknesses
- produce a Personal Development Plan (PDP).
