Criteria For Winning The BTEC HN Video Competition

We are looking for enthusiastic students who would like to share their BTEC Higher National experience with the world. The selection criteria will include:

- Content relevance
- Originality
- Professionalism
- Creative/appropriate use of location
- Expresses the diversity of both HN subjects and students' place of study
- Quality of the video
- Quality of the audio

Video Competition Guidelines

- The following questions should be used as a guideline for the content of your video:
 1. *Why did you choose a BTEC Higher National?*
 2. *What is the best feature of your BTEC Higher National course?*
 3. *How will this course help you in your future career?*
 4. *If you were talking to a prospective BTEC Higher National student, how would you promote the experience of studying a BTEC Higher National?*
- The video must be shot in landscape (horizontal)
- The video must only include yourself and must not include anyone else
- The video must be no longer than 30 seconds and must be supplied in MOV, MPEG-4, or WMV format.
- You must be looking at the camera
- Be as candid and informative as possible
- Do not be too centre-specific, the aim is to showcase your own experience and what you value about your BTEC Higher National course
- Videos must not feature any copyrighted 3rd party music, SFX, VFX, graphics, photography or other elements. If copyright infringement is suspected, we may ask entrants to provide evidence of the licenses / permissions and reserve the right to disqualify any entries found in breach of international copyright law.
- The films submitted into the competition must adhere to the following requirements:

- Films must be the original work of the team and must not infringe any third-party's rights or ownership.
- All films must be suitable for publication on mainstream media and social media websites, and not contain obscene or indecent material
- All entries must not contain obscene or pornographic material; may not contain defamatory statements about any person, company, organisation or entity
- The film and the production of the entry must not invade privacy or other rights of any person, company or entity
- All entries must not in any other way violate applicable laws and regulations; and may not contain any copyrighted elements not owned by the team
- Films containing prohibited or inappropriate content as determined by Pearson, in its sole discretion, to be inappropriate will be disqualified
- Entrants agree to indemnify Pearson from and against any and all liability arising from their nomination infringing any third party intellectual property rights (including without limitation copyright) being defamatory, libellous, or otherwise unlawful. All material submitted as part of the entry and the copyright in such material shall become the property of Pearson.

Submitting Entries

- Submit your video by emailing it to highernationals@pearson.com with **BTEC Higher National Video Competition** in the subject line. If the file is too big, you will need to send it through **Google Drive**.
- The email should include:

Your name, contact details, your centre, your place of study, the BTEC Higher National you are currently undertaking, and why you think we should select your video over others.

- Entries must be received by **Friday 17 March, 2017**. Entries received after this date will not be considered.

Prizes

Pearson will select the top 10 videos received and will award a **£50 Amazon voucher** for each video selected. Winners will be contacted by **Friday 24 March, 2017**.
