New BTEC Bulk Certification Claims Service



The new BTEC bulk claims functionality is now live on Edexcel online.

This allows you to claim for certification for more than one learner at the same time. If you're registered on Edexcel Online as an Exams Manager, Officer or Assistant you will already have access to this service.

BTEC: Reporting Learner Achievement



There are three methods to report results:

- SRF (student report forms)
- Individual or bulk claims on Edexcel Online
- EDIFACT EDI

The deadline for the submission of BTEC certification claims using SRFs is the 5th July, for certificates to be in centres by the 15th of August (NB: This only applies to QCF programmes, NQF certificates will be issued in line with the GCSE certificates, and should be in centres by the end of October).

The final date for Edexcel Online certification claims is the 25th July.

Please ensure that you report results for UCAS applicants as early as possible so that we can inform UCAS in time.

To help support your learners we have extended the registration deadline to Friday 11th July.

What is ResultsPlus Direct?

ResultsPlus Direct is a free service that allows your students to view their Edexcel grades online on all results days, including August.



The service offers four big enhancements:

- greater detail, with question-by-question analysis, highlight reports and skills maps for each student
- accessible and optimised for all devices
- a lifetime account allowing students to view results from more than one series
- mock exam reports to support teachers setting past paper mocks.
