

November 2014 GCSE English and Mathematics re-sits

From this year, the November GCSE exam series is only available for candidates re-sitting English, English Language and Mathematics. Candidates who have completed and been issued with a result in these subjects by Edexcel or another awarding organisation can be re-entered in the November 2014 series. A candidate who has previously sat English may be entered for English Language and vice-versa.



A candidate who was entered for a subject in a previous series but obtained a "no result" may not be re-entered in the November series.

Marks for controlled assessment and the Speaking and Listening endorsement for English and English Language can be carried forward from previous exam series as long as they have been "cashed-in" for a subject award. If you would like to use results from previous series, you do not need to make unit entries for the relevant papers and the marks will be carried forward automatically. Please note that controlled assessment marks cannot be transferred between different awarding organisations.

Please make sure that you submit your entries for the November 2014 GCSE exam series by the entry deadline of 4 October 2014.

Pearson Onscreen Platform upgrade coming soon



An upgraded version of the Pearson Onscreen Platform will be available on **Tuesday 30 September 2014**. The upgrade includes several software enhancements and improved performance.

This new version of the software also features new functionality to allow the platform to be used with more qualifications. It also offers a new offline facility to deliver tests without an active internet connection.

Reminder: QCF Accreditation for Lead Internal Verifiers 2014-2015

It is essential that each Lead Internal Verifier (LIV) confirms their status for their specified programme(s) on OSCA which can be accessed via Edexcel Online by **30 September**.



For any LIVs that also need to undertake online standardisation, the only window this year will be:

Window Opens	Window Closes	Results Released
21 August 2014	5 November 2014	12 November 2014

All QCF qualifications that require Lead IV accreditation will be available in this window.

Internal Assessment for BTECs



There is new guidance for the Internal Assessment of BTEC Firsts and Nationals for students first being taught from 1st September 2014. Full details of the guidance is available [here](#).

The new guidance does not apply to any student who was being taught before 1st September 2014 or who "tops up" to a larger qualification following year (2014-2015) for example, topping up to a BTEC National Extended Diploma. A "top up" of this kind effectively re-opens the learner's existing registration, and they therefore count as still "on programme" and part-way through their course on 1 September 2014.
