Keeping you informed

There have been a number of announcements recently from the English Department for Education concerning the reform of Ofqual (Office of Qualifications and Examination Regulation in England) regulated GCSE and GCE A level qualifications.

GCSE reform

- New GCSEs in English literature, English language and Mathematics, to be introduced for first teaching from September 2015.
- These GCSEs will have new content, be linear in structure and will be assessed and graded differently from the current GCSEs. The new grading scale will be 1-9, with 9 being the top level.
- New GCSEs in other subjects will be introduced from 2016.

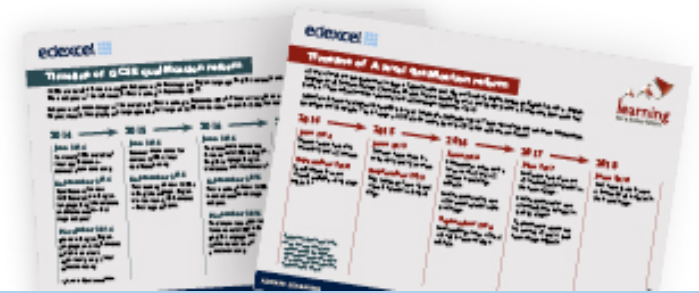


GCE A level reform

- 14 new GCE A levels will be developed for 2015, for first assessment in 2017. These GCE A levels are to be fully linear with more synoptic assessment.
- AS levels to be stand alone qualifications for first teaching from September 2015. AS levels will no longer contribute to a GCE A level grade. Their purpose will be to encourage curriculum breadth and they will remain broadly at their current standard.
