


Exams Officer Update- September 2014



Late Cash Ins

We can process late cash ins for GCE until 20 September 2014.

Please email these to PQS.InternationalEO@pearson.com with your centre number, candidate name, candidate number, UCI and the cash in code required. The result will show on Edexcel Online the day after this is processed.

Please note that we are unable to accept any late cash in requests for GCSE qualifications. This is an OfQual ruling and more information can be found on their website [here](#).



Missing Results

If you find you are missing any externally assessed unit results for a candidate, please send the candidate and unit details along with a copy of the relevant register, to resultsresolution@pearson.com.



UCAS

For academic qualifications we will be sending results to UCAS daily from 12 August until 3 October. Files are sent at midday (BST) and then UCAS will process these the next day so please be aware that there can be a slight delay.

Post-Results Services and Re-marks

Post-Results Services has been available for GCE and Level 3 Project from Thursday 14 August 2014 and 21st August 2014 for GCSE, International GCSE and DiDA.

Please remember that the Enquiry About Results Priority Service and Access To Script Photocopy is not




available for GCSE and other Level 2 qualifications. This means for GCSE, you cannot review a candidate's script before ordering a re-mark.

Replacement Certificate fees

Please note the 2014/2015 fee for requesting a reprint certificate is now £38.

If you are requesting a reprint of BTEC certificate there will be no charge within one month of the certificate print date. Requesting a reprint certificate after the one month deadline will be subject to a reprint fee.

Reprint certificates for General Qualifications will be charged at the reprint fee of £38. If you have received confirmation that a grade has changed following a post results enquiry there will be no charge in reprinting as long as a copy of the post results confirmation letter and the old certificate are returned to your Account Specialist at the following address:
