We have previously informed you that the post results services dates had been omitted from the "Key Dates" section of your Information Manual. We can confirm that the dates for all January general qualifications including International GCSE and IAL are as follows:

Results released and Post Results services available: 5th March 2015

Last date to receive Enquiry about Results requests: 14th April 2015

Last date to receive Access to Scripts requests: 16th April 2015

Reminder: Entry deadline for June 2015 examinations



Following JCQ guidelines to change the June 2015 examinations entry deadline to 21st February 2015 in the UK, Please note that deadline date for IAL, International GCSE, GCSE, GCE, PLSC and DiDA entries for international centres will remain to be on the 21st March 2015 as with previous years. Any entries received after the entry deadline may incur a late fee. Please see below for the other associated dates:

Entry deadline: 21st March 2015

Amendment deadline: 21st April 2015

Final date by which withdrawn entries will be refunded: 21st April 2015

Higher late fees may apply from this date: 22nd April 2015
