Notes on the Completion of the Special Consideration Form

1. **A separate Special Consideration Form 10 must be completed for each candidate, for each specification, listing all units/components affected in the same specification.**

Please submit form 10 to Pearson within 7 days of the final formal assessment for 5PE02 & 5PE04.

2. Please fill in the details at the top of the form, specifying the examination series concerned e.g. June and the date(s) of the formal assessment.
3. Please fill in the details required in the box 'UNIT FOR WHICH APPLICATION IS MADE' specifying the unit affected e.g. 5PE02 or 5PE04 and ticking the appropriate box to indicate whether the candidate was absent or present but disadvantaged (*Definition below*).
Absent - where a candidate is unable to complete one or more parts of the unit.
Present - completed all parts of the unit but was affected by illness/injury.
4. For candidates that missed some of the GCSE PE Practical unit (5PE02 or 5PE04) please note that we require the candidate's **actual or estimated** marks for each of the 4 practical activities (2 for 5PE04).
